QUOTE: PROTESTANT CHURCHMENT SMARTING UNDER ALLEGATIONS IN THE ENESSET THAT CHRISTIAN MISSIGNARIES BAD BRIBED ISRAELIS IN ORDER TO CONVERT THEM DAVE CALLED FOR AN INDEPENDENT INTERNATIONAL COMPASSION TO INVESTIGATE THE "CIRCUMSTANCES AND CONSIDERATIONS" THAT HAVE LED CHRISTIANS, JEWS & MUSLIMS IN ISRAEL TO CHANGE THEIR RELIGION. REV HENRY KNIGHT AN ANGLICAN PRIEST SPEAKING FOR THE UCCI YSERDAY SAID THAT THE FINDINGS WOULD "FAIN" ISHAELIS. THEY WOULD SHOW THAT CONVERTS TO CHRISTIANITY HAD NOT BEEN SUBJECTED TO IMPROPER INDUCEMENTS WHILE THOSE EMBRACING JUDAISM HAD BEEN UNDER SOME PRESSURE. HE POINTED TO STATUTORY REGULATIONS THAT PROBABLY MOTIVATED SOME CONVERSIONS TO JUDAISM. MARRIAGE LAWS REQUIRE BOTH PARTNERS TO BE OF THE SAME RELIGION & AND A SUBSTANTIAL NUMBER OF PEOPLE ACCEPTED THE FAITH OF THEIR PROSPECTIVE PARTNERS IN ORDER TO MARRY THEM. IMMIGRATION AND CITIZENSHIP LAWS DISCRIMINATED IN FAVOUR OF JEWS AND SOME PEOPLE MIGHT HAVE BEEN MOVED TO EMBRACE JUDAISM IN ORDER TO HERE WILL DEAL WITH SUCH BENEFITS IN A PERSON'S DECISION TO CONVERT TO JUDAISM, " MR KNIGHT SAID." THE CAMPAIGN BY THE UCCI IS PART OF ONE FOR THE REPEAL OF A LAW ENACTED LAST MONTH WHICH MAKES IT A CRIMINAL OFFERE TO OFFER MATERIAL BENEFITS TO INDUCE PEOPLE TO CHANGE THEIR RELIGION. THE LAW ITSELF DOES NOT MENTION CHRISTIAN MISSIONARIES BUT THE SPONSOR'S EXPLANATORY NOTE AND REMARKS BY DEFUTIES DURING THE KNESSET DEBATE LEFT NO DOUBT THAT LT AIMED AT CURBING THEIR ACTIVITIES. REV ROY KREIDER A MENONITE & VICE CHAIRPAN OF THE UCCI EXECUTIVE SAID THAT THE CHURCHMEN'S POSITION WAS EXPLAINED IN A MEMORANIUM SENT LAST WEEK TO PROF AHARON BARAK, THE ATTORNEY GENERAL.

QUOTE: REV DOUGLAS MACGREGOR OF THE SCOTTISH CHURCH ACTED AS THE NEXT REV KATZ DID IN "THE BRAVE SOLDIER SCHWEIK" DID AND AS THE MEN OF THE SALVATION ARMY IN BRITIAN AS DESCRIBED MOCKINGLY IN THE PLAY "MAJOR BARBARA" OF BERNARD SHAW: HE USED ENTICEMENTS IN ORDER TO DRAW NEAR ERRING SOULS OR SINNERS NEAR TO THE BOSON OF GOD AND WHAT IS EVEN MORE IMPORTANT TO THE BOSON OF THE CHURCH. AT THE BEGINNING OF THE YEAR REV MACGREGOR CAUGHT A YOUNG HOUSEBREAKER IN HIS NAZARETH FLAT: WHEN HE ARRIVED HOME HE HEARD A SUSPICIOUS NOISE AND ENTERING THE ROOM WHERE THE NOISE WAS HE FOUND A STRANGE MAN GATHERING VARIOUS OBJECTS INTO A PACKAGE. AT THE SIGHT OF THE OWNER OF THE HOUSE THE YOUNG HOUSEBREAKER BURST INTO TEARS AND RELATED THAT HE ALREADY HAS 100 FILES IN THE POLICE RECORDS AND THAT HE FEARS IMPRISONMENT. THE WORDS OF THE YOUTH TOUCHED THE COMPASSIONATE REVEREND AND AFTER A LITTLE LIGHT THINKING HE MADE A DEAL WITH THE YOUNG MAN: THE YOUTH WOULD COME TO STUDY IN ONE OF THE SCHOOLS OF THE MISSION AND IN EXCHANGE FOR THIS HE WOULD NOT BE TURNED OVER TO THE POLICE. AFTER A WHILE THE YOUNG MAN APPEARED AT THE REVEREND'S PLACE, AND NOT ONLY BY HIMSELF BUT WITH A COMPANION, AND THE TWO OF THEM ASKED TO BE SENT TO PURIFYING STUDIES. THEY WERE SENT TO THE MISSION SCHOOL IN JERUSALEM. AS IS KNOWN SEVERAL WEEKS AGO AN ESSENTIAL, URGENT, HUMANE AND UNIQUELY LIBERAL LAW WAS PASSED, ACCORDING TO WHICH SEVERE PENALTIES ARE TO BE INVOKED AGAINST MISSIONARIES EMPLOYING ENTICEMENTS. DELICATE SOULS LIKE MERR PEIL, MENAHEM WIRSHUVSKY AND SHULAMIT ALONI LET OUT A GREAT OUTCRY. IT WOULD SEEM THAT NOW THEIR ALLEGATIONS WILL BE STOPPED IN VIEW OF THE EN-TICEMENT XWRXXXX EMPLOYED BY REV MACGREGOR TOWARD A MARDENED YOUNG HOUSEBREAKER WHO SHOULD BE SITTING IN JAIL. THE LEGAL ADVISER AND GOV'T PROSECUTING ATTORNEY ARE HEREBY REQUESTED TO ACT MEASURET IN ACCORDANCE WITH THE LA W AGAINST MISSIONARY ACTIVITY.

CONVER-SION SIGNIFIES NOTHING TO A JEW. THERE IS NO FAITH IN THIS NEW TESTAMENT WHICE IS THE CONDITION, ACCORDING TO A CHURCH HEAD, FOR BEING A CHRISTIAN. THE FARRANGS OF THE INQUISITION HAVE WELL PROVED THIS. PUTTING A CROSS ON A JEW DOES NOT MEAN THE SUPPRESSION OF WHAT IS JEWISH IN HIM. HET WAS BORN A JEW-AND SO KKK REMAINS:

LETTER TO EDITOR DATE: 9.2.78 JOURNAL: JERUSALEM FOST (ENGLISH) HEADING: "KEREN YALDENU" SIGNED: MALKA FRAENKEL, PRESIDENT KEREN YALDENU INC QUOTE: IN YOUR ISSUE OF FEB 1 YOU REPORT THAT AT A PRESS CONFERENCE HELD BY THE UCCI INXIERK KEREN YALDENU WAS DESCRIBED AS BEING "A VERY VICIOUS ORGANISATION MISLEADINGLY CALLED KEREN YALDENU (OUR CHILDREN'S FUND). " THE GENERALLY ACCEPTED MEANING OF THE WORD "VICIOUS" AS APPLIED TO PERSONS IS ACCORDING 10 THE OXFORD ENGLISH DICTIONARY ADDICTED TO VICE OR IMMORALITY, OF DEPRAVED HABITS, PRO-FLIGATE, WICKED. OUR ORGANISATION PROVIDES AFTERSCHOOL ACTIVITIES FOR CHILDREN AND YOUNG PEOPLE BE-TWEEN THE AGES OF 7 & 15. THESE ACTIVITIES CONSIST IN THE MAIN OF ELECTRONICS, CHEMISTRY, MATH, ENGLISH, JEWISH STUDIES (BIBLE, HISTORY, ETHICS) ARTS & C RAFTS, HOME ECONOMICS AND SPORTS. GREAT EMPHASIS IS PLACED ON TEAM WORK, CIVIC PRIDE AND THE APPRECIATION OF OUR HERITAGE. THE OBJECT OF ALL OUR COURSES IS TO ENCOURAGE THE CHILD TO THINK AND ACT LOGICALLY AND TO APPRECIATE THE VALUE OF LEAFNING. OUR CENTRES ARE MAINLY SITUATED IN A REAS WHERE THERE ARE CHILDREN IN GREAT NEED OF THE HELP OUR COURSES GIVE. WE ALSO RENDER PRACTICAL ASSISTANCE TO CHILDREN IN NEED OF FOOD AND CLOTHINGNAL AND IF NECESSARY GIVE EMERGENCY FINANCIAL GRANTS TO THEIR FAMILIES. OUR LARGER CENTRES ALSO ACT AS A MEANS OF BREAKING DOWN THE BARRIERS BETWEEN CHILDREN FROM DIFFERENT SOCIAL AND ETHNIC BACK-GROUNDS. FOR EXAMPLE IN ROMEMA (JERUSALEM) WE HAVE 1600 CHILDREN WEEKLY FROM 47 DIFFERENT SCHOOLS OR IN A SHOOD FROM 17 DIFFERENT SCHOOLS WE CONSIDER THE ENABLING OF THESE CHILDREN TO LEARN AND PLAY TOGETHER AND TO BECOME GOOD FRIENDS A MOST IMPORTANT ASPECT OF OUR WORK. OUR A COUSERS WERE CORRECT ABOUT ONE POINT AND THAT IS THAT WE GET SUPPORT FROM THE MIN OF RELIG AFFAIRS. BUT WE ALSO GET SUPPORT FROM THE MINISTRIES OF SOCIAL WELFARE AND EDUCATION. WE ALSO RECEIVE HELP FROM CHRIS-TIAN DONORS, CHURCHES AND ORGANIZATIONS WHO HAVE EXAMINED OUR WORK IN DEPTH AND ARE PLEASED TO SUPPORT WHAT THEY DESCRIBE AS "HOLY WORK." CAN ALLW OR ANY OF THESE ACTIVITIES BY ANY STRETCH OF THE IMAGINATION BE CALLED VICIOUS? MAY I CONCLUDE BY MENTIONING THAT TO CATER FOR OUR CURRENT REGISTRATION OF SOME 10,000 YOUNGSTERS IN OUR 25 CENTRES WE HAVE TO RAISE 65PERCENT OF OUR BUDGET (CURRENTLY IL 2m. in deficit) FROM VOLUNTARY CONTRIBUTIONS. MOST CLUBS HAVE A WAITING LIST OF THOSE WISHING TO JOIN-BUT WE ARE FORCED TO LIMIT THE SCOPE OF OUR WORK TO THE AMOUNT OF MONEY AVAILABLE . "

BYLINE: SHLOMO SHAPIR EXTRACTS: "NORWAY WHICH IS A NATO MEMBER BUT HAS NOT JOINED THE WEST BUROPEAN COMMON MARKET LIKE DENMARK IS STILL RECKONED AS THE MOST FRIENDLY NATION AMONG THE SCANDANAVIAN COUNTRIES TO US ... (COMMENTS ABOUT THE SETTLEMENTS AND EFFECT ON NORWEGIAN POLICY IN MIDEAST) WITH THE RETIREMENT OF THE CHAIRMAN OF THE CHRISTIAN POPULIST PARTY FROM PARLIAMENT TINNES WAS CHOSEN AS CHAIRMAN OF THE LEAGUE OF FRIENDS OF ISRAEL WHICH NUMBERS IN ITS RANK AT PRESENT 107 OUT OF 155 MEMBERS OF THE NORWEGIAN PARLIAMENT. THIS IS AN INCREASE IN RELATION TO THE OUTGOING PARLIMANET WITH 86 MEMBERS IN THE LEAGUE. IN PART THIS IS THE RESULT OF A DECLINE OF THE EXTREME LEFTIST PARTY FROM 16 TO 2 MAN DATES. ABOUT 60 PERCENT OF THE MEMBERS OF THE FRIENDSHIP LEAGUE ARE REPRESENTATIVES OF THE NONSOCIALIST FARTIES, THE CHRISTIANS, THE CONSERVATIVES AND THE FARMERS, AND A BOUT 40 PERCENT ARE REPRESENTATIVES OF THE RULING LABOUR PARTY. AS WILL BE RECALLED, THE LABOUR PARTY REMAINED IN POWER THANKS TO A PAJORITY OF SEVERAL DOZEN VOTES IN ONE OF THE DISTRICTS. OTHERWISE, TINNES WHO IS NOW THE CONSERVATIVE REPRESENTATIVE IN THE FOREIGN AFFAIRS COMMITTEE WOULD BE HOLDING ONE OF THE IMPORTANT POSTS IN THE GOVERNMENT. ACCORDING TO TINNES THE SETTLEMENTS ARE NOT THE SOLE FACTOR BEHIND MISUNDERSTANDING. NO LESS A FACTOR IS THE APPREHENSION FELT AWARK IN THE CHRISTIAN COM-MUNITY ABOUT THE NEW LAW AGAINST THE MISSION PASSED BY THE KNESSET AND INTERPRETED AS AN ATTEMPT TO BURT THE ACTIVITIES OF THE CHRISTIAN CHURCHES. ONE MUST TAKE INTO ACCOUNT THE FACT THAT THE MAIN SUPPORT FOR ISRAEL IN NORWAY STEMS FROM A RELIGIOUS BACKGROUND. THE CHRISTIAN POPULIST PARTY IS A PRO-ISRAEL PARTY WITH A VENGEANCE. ALL ITS MEMBERS OF PARLIAMENT ARE MEMBERS OF THE LEAGUE OF FRIENDS (OF ISRAEL). ALSO IN THE OTHER PARTIES THE INFLUENCE OF RELIGION IS NOT INSIGNIFICANT. NORWAY IS WITHOUT A DOUBT THE MOST CERISTIAN AMONG SCANDANAVIAN COURT RIES, AND THIS IS ESPECIALLY OBVIOUS IN CERTAIN AREAS OF THE COUNTRY. ISRAEL MUST DO EVERYTHING TO A VOID UND ERMINING THIS SYMPATHY FOR HER, WHICH IS THE BASIS FOR UNDERSTANDING BETWEEN THE TWO PEOPLES AND THE TWO STATES. THE FACT THAT SADAT HAS RECENTLY DRAWN NEAR TO THE WEST AND EMPHASIZES HIS ANTICOMMUNIST MISSION DOES NOT AFFECT NORWAY-ISRAEL RELATIONS SINCE SYMPATHY FOR US IN ANY CASE DOES NOT STEM FROM A VIEW OF ISHAEL AS AN ANTICOMMUNIST FORTRESS IN THE MIDEAST, NOT EVEN AMONG CONSERVATIVES.
