THE BILL, WHICH THEY BELIEVED WOULD BE WATERED DOWN INTO A FORM OF LIPSERVICE TO FANATICAL ELEMENTS, EMERGED INTACT. THE LAW ITSELF LOES NOT DISCLOSE ITS ANTICHRISTIAN INTENT. HOWEVER, THE EXPLANATORY TEXT TO THE DRAFT LAW (WHICH WAS FIRST MOCTED BY RABBI ABROMOVITZ OF THE ULTRA-RELIGIOUS ACUDAT ISRAEL) IS EXPLICIT: "THE AIM OF THIS LAW IS TO PUT A STOP TO THE AC-TIVITY OF THE ORGANIZATIONS OF THE (CHRISTIAN) MISSION BY MEANS OF PROHIBITING ALL MISS-ICNARY ACTIVITY ACCOMPANIED BY MATERIAL ENTICEMENT." THOSE WHO "GIVE OR PROMISE TO GIVE MONEY, AN EQUIVALENT, OR OTHER MATERIAL BENEFIT TO ENTICE A PERSON TO CHANGE HIS RELIGION" WILL BE LIABLE TO FIVE YEARS' IMPRISONMENT IL50,000 (\$3,000). THOSE WHO ARE OFFERED EN-TICEMENT FACE A THREE YEAR IMPRISONMENT OR A FINE OF IL30,000 (\$2,000). RABBI ABRAMOVITZ HAS BEEN QUOTED AS SAYING "THE MISSICNARIES HAVE UNLIMITED FUNDS...AND PROMISE HUGE SUMS OF MONEY TO ENCOURAGE PEOPLE TO EMIGRATE AND CHANGE THEIR RELIGION. THEY TRY TO INFLUENCE SCIDIERS AND PERSUADE THEM TO DESERT." AS A MEMBER OF KNESSET HE IS IMMUNE FROM LIBEL LAWS AND CANNOT BE DIRECLY CHALLENGED ON WHAT THE MISSIGNARIES AND MANY OTHERS CONSIDER TO BE DEFAMATORY STATEMENTS. THE UCCI SENT A MESSAGE TO ISRAELI LEADERS "EXPRESSING IN THE STRONGEST POSSIBLE TERMS ITS SENSE OF SHOCK AND INCREDULITY AT THE HASTY PASSING OF THE LAW." AS A UCC SPOKESMAN EMPHASIZED, IT IS NOT MERELY THE CONTENTS OF THE LAW THAT O NCERNS THEM BUT THE FACT THAT THE BILL WAS PUSHED THROUGH THE KNESSET WITH INDECENT HASTE AT A TIME WHEN CHRISTIANS WERE BUSILY ENGAGED IN PREPARING FUR THEIR MAJOR ANNUAL FESTIVAL. THE ISRAELI LEADERSHIP HAS CHOSEN TO IGNORE THE PROTEST AND THE UCC HAS BEEN FORCED TO APPEAL FUR INTERNATIONAL SUPPORT. WHEN MOSHE DAY AN VISITED THE MATICAN RECENTLY HE WAS (ACCORDING TO RELIABLE SOURCES) QUESTIONED ON AN ADVERSE REPORT ON THE LAW BY BISHOP WILLIAM CARRIE, THE APOSTOLIC DELEGATE IN JEHUSALEM. ON HIS RETURN TO ISRAEL, DAYAN WAS ALSO ASKED TO COMMENT ON A PROTEST WHICH HAD BEEN HANDED TO US AMBASSADOR SAMUEL LEWIS BY SIX US MISSIONARIES. THEY ACCUSE THE ISRAELI AUTHORITIES OF FAILING TO ARREST AND PUNISH THE CRIMINALS WHO BOMBED A . BAPTIST'S HOUSE IN WEST JERUSALEM, AND THOSE WHO AT-TACKED THE HOME OF CHRISTIANS OF JEWISH ORIGIN IN THE VILLAGE OF ROSH PINA. THE AMBASSADOR PROMISED TO CONVEY THE PROTEST TO PRES CARTER. LEWIS REMARKED THAT HE HAD RECEIVED A SIMILAR PROTEST SOME 20 YEARS PREVIOUSLY WHILE A DIPLOMAT IN AFGHANISTAN, BUT THAT HE DID NOT EXPECT TO REPEAT THE EXPERIENCE IN 1978 IN TELAVIV. AS THE LIBERAL ISRAELI DAILY HAARETZ SAID IN AN EDITORIAL: "THE LAW IS BAD AND UNNECESSARY." IT IS ESTIMATED THAT EACH

QUOTE: "A THREE-MAN DELEGATION FROM THE UCC OF JERUSALEM ARRIVED IN GENEVA LAST WEEK TO OPEN AN "INFORMATION CAMPAIGN" AGAINST THE ISRAELI "MISSION BILL" APPROVED BY THE KNESSET LAST DECEMBER. THE BILL FORBIDS THE OFFER OF MATERIAL INDUCEMENTS TO CANDIDATES FOR CONVERSION. THE DELEGATION (MADE UP OF AN ARAB CHRISTIAN CLERGYMAN, A NORWEGIAN LUTER-AN PASTOR AND A ROMAN CATHOLIC LAYMAN) MET LEADERS OF THE WCC WHICH REPRESENTS NEARLY 30C CHURCHES IN MORE THAN ONE HUNDRED CUNTRIES. LATER THE WCC ISSUED A PRESS STATEMENT SAYING THAT THE DELEGATION HAD EXPRESSED "THE DEEP CONCERN OF ALL CHRISTIANS" ABOUT THE BILL, THE STATEMENT SAID THE BILL WAS "CONSIDERED BY THE DELEGATION A THREAT TO THE HUMAN RIGHTS OF THE CHRISTIAN MINCRITY IN ISRAEL AND TO COEXISTENCE BETWEEN CHRISTIANS & JEWS THREE." MR AHAR IN ABUHATZEIRA, ISRAEL'S MINISTER OF RELIGIOUS AFFAIRS, AND OTHER GOV'T MEMBERS SAY THAT THE NEW LAW WILL NOT INHIBIT ANY LEGITIMATE CHRISTIAN ACTIVITIES. THE CHRISTIAN DELEGATION FROM ISRAEL IS VISITING A NUMBER OF COUNTRIES TO LOBBY SUPPORT FOR ITS CLAIMS. TULLIA ZEVI REPORTS FROM ROME: "AT THE REQUEST OF THE CATHOLICS, THE MISSION BILL WILL BE DISCUSSED ATT HE FORTHCOMING MEETING IN MADRID OF THE INTERNATIONAL CATHOLIC AND JEWISH LIAISON COMMITTEE. MSR JORGE MEJIA (SECY OF VATICAN'S COMMISSION FOR RELIGIOUS RELATIONS BETWEEN THE CHURCH & JUDAISM) SAID THAT THERE DID NOT SEEM TO BE THE NEED. FOR SUCH A LAW IN ISRAEL, BUT BECAUSE IT WAS WORKYING CHRISTIANS IN ISRAEL, THE COMMITTEE HAD TO CONSIDER THE PROBLEM. THE JEWISH DELECATION WILL INCLUDE REPRESENTATIVES OF THE WORLD JEWISH CONGRES THE AMERICAN JEWISH COMMITTEE, BNAI BRITH, THE SYNAGOGUE COUNCIL OF AMERICA (REPRESENTING ORTHODOX, CUNSERVATIVE & REFORM JUDAISM IN THE U.S.) AND ISRAEL'S JEWISH COUNCIL FOR INTER-RELIGIOUS AFFAIRS. THE VATICAN COMMISSION WAS FOUNDED BY POPE PAUL IN 1974 TO IMPLEMENT THE ECUMENICAL COUNCIL'S 1965 "DECLARATION ON THE JEWS." UNQUOTE

FAILING TO WIN A SYMPATHETIC HEARING, DEPUTATIONS OF CATHOLIC & PROTESTANT CHURCHMEN HAVE TRAVELED ABROAD DURING THE PAST TWO WEEKS TO LODGE PETITIONS WITH THE POPE, THE ARCHDISHOP OF CANTERBURY & THE WCC. THE CHURCHMEN ARE SEEKING SUPPORT IN OTHER COUNTRIES IN ORDER TO BRING PRESSURE TO BEAR ON THE ISRAELI GOV'T TO REPEAL THE LAW. MEMBERS OF THE GOV'T AND THE KNESSET (INCLUDING MR AHARON ABU HATZEIRA, THE MIN FOR RELIG AFFAIRS) HAVE REITERATED TO REPRESENTATIVES OF THE CHRISTIAN GROUPS THAT THE LAW WILL NOT INHIBIT LEGITIMATE CHRIS-TIAN ACTIVITIES IN ISRAEL. HOWEVER, THE PROTESTING CHURCH GROUPS WHO HAVE FORMED A "UNITED CHURCH COUNCIL" WERE NOT PACIFIED. THEY SENT A TELEGRAM TO MR MENAHEM DEGIN, THE PM, CALL-ING HIS ATTENTION TO WHAT THEY REGARD AS A SERIOUS BLOW TO RELIGIOUS FREEDOM. MOST OF ISRAEL'S 80,000 CHRISTIANS ARE ARAB MEMBERS OF THE ORTHODOX CHURCHES WHO DO NOT FEEL DIRECT-1y INVULVED. THE GROUPS WHICH ARE CONCERNED ARE CATHOLICS, WHO FEAR THAT THEIR WORK. THROUGH THEIR MANY SCHOOLS AND WELFARE INSTITUTIONS WILL BE CURBED, SOME WESTERN PROTESTANT CHURCHES ACTIVE IN A SMALL WAY IN ISRAEL, AND ABOVE ALL, MESSIANIC GROUPS OF FORMER JEWS WHO HAVE BECOME CONVERTS TO CHRISTIANITY. IT HAS BEEN ESTIMATED THAT THE PROTESTING GROUPS REPRESENT LITTLE MORE THAN 5,000 : PEOPLE. HOWEVER, EVEN CONFIRMED CHRISTIAN SUPPORTERS OF ISRAEL LIKE DR G DOUGLAS YOUNG (PRESIDENT OF AMERICAN INSTITUTE OF HOLY LAND STUDIES IN JERUSALEM) HAVE EXPRESSED MISGIVINGS ABOUT THE LAW. HE IS CHAIRMAN OF THE NEWLY FURMED "INTERNATIONAL CHRISTIANS FOR ISRAEL" CRGANIZATION, WITH AN OFFICE IN JERUSALEM, WHICH PLANS TO WIDEN THE SUPPORT OF COMMITTED CHRISTIANS OVERSEAS FOR "BIBLICAL IDENTIFICATION WITH ISRAEL." THE NEW ORGANIZATION WES ESTABLISHED BY SEVERAL HUNDRED REPRESENTATIVES OF VARIOUS EVANGELICAL CHRISTIAN CHCUPS FROM TEN COUNTRIES WHO MET IN ISRAEL LAST WEEK TO EXPRESS THEIR SCLIDARITY WITH THE JEWISH STATE." THE LAW SPONSCRED BY THE ORTHOXX RABBI OF AGUDAT ISRAEL YEHUDA MEIR ABRAMOWITZ TAKES EFFECT ON APRIL 1st LAYS DOWN PENALTIES OF FIVE YEARS IMPRISONMENT FOR ANYONE OFFERING MONEY OR OTHER MATERIAL BENEFIT TO CAUSE ANOTHER TO CHANGE HIS RELIGION, AND THREE YEARS IMPRISON-MENT FOR ANYONE ACCEPTING SUCH AN OFFER. THE LAW HAS STIRRED UP A NOTABLE CONTROVERSY ... WITHIN THE STATE OF ISHAEL AND HAS STRAINED HELATIONS AMING ITS 80 OCC CHRISTIANS....IN THE JEWISH STATE THERE LIVE CHRISTIANS AND MUSLEMS AS MINORITIES. THE CITY OF JERUSALEM IS HOLY TO ALL THREE RELIGIONS....ALTHOUGH THE NEW IAW DOES NOT NAME CHRISTIANS...IT WAS CLEAR FROM THE OUTSET AGAINST WHOM IT WAS DIRECTED. IT IS ESPECIALLY THOSE WHO CONVERT TO JEHOVA WITNESSES WHO CONSTITUTE A FROBLEM FOR THE STATE OF ISRAEL. THE CHIEF COMMAND OF THE JW'S IS OPPOSITION TO MILITARY SERVICE. MORE THAN ONE SUCH CONVERT HAS FOR REFUSAL TO SERVE IN THE MILITARY SAT IN PHISON. THE LARGER, RECOGNIZED CHURCHES DO NOT PURSUE MISSICNARY (ACTIVITIES)... . THERE ARE SMALL SECTS AND PRIVATE GROUPS WHICH CHARACTERIZE THEMSELVES AS "JEWISH CHRISTIANS" OR "MESSIANIC JEWS". THEY OPERATE BIBLE CENTRES SICH AS THE CNE HUN BY SCHLOMO HASAK, THE FURMER BODYGUARD OF BENGURION, WHO MAKE THEMSELVES/DISLIKED EVEN BY LITERAL ISRAELIS WHO GENERALLY FAVOUR FULL RELIGIOUS FREEDOM. SOME OF THESE MISSIGNARY BRUCHURES DISPLAYED IN BIBLE CENTRES IN JEHUSALEM WERE SHOWN BY RABBI LAU IN THE TELEVISION DISCUSSION. THEY ALL APPEAR EXTERNALLY TO BE JEWISH PUBLICATION: WRITTEN IN HEBREW AND ADDRNED WITH JEWISH SYMBOLS. IT IS ONLY IN THE TEXT THAT REFERENCE IS MADE TO THE MESSIAH JESUS CHRIST...FRINGE GROUPS SUCH AS THESE ARE NOT ESPECIALLY LOVED THERE IS ALSO THE PROBLEM IN ISRAEL. " OF THE GENERAL ISRAELI IGNORANCE OF CHRISTIAN MATTERS. CNLY A FEW PAGES IN ISRAELI HISTORY BOOKS ARE DEVOTED TO THE RELIGIOUS FOUNDATIONS OF CHRISTIAN FAITH, EVEN LESS THAN ABOUT FRIENDLY CUNTACT BETWEEN JEWS, CHRISTIANS AND MUSLEMS...ARE FEW EXCEPT IN INTEL-LECTUAL CIRCLES SUCH AS THE INTERFAITH COMMITTEE OR THE HAINBOW CLUB. (THERE IS A REFER-ENCE AND BRIEF DESCRIPTION OF THE CTTOMAN "MILLET" SYSTEM.) PROBLEMS AMONG THE RELIGIOUS BODIES ARE EASILY CREATED BY FANATICS IN ALL THREE CAMPS. THERE ARE YOUNG MOSLEMS WHO ESPECIALLY FOLICWING FRIDAY WORSHIP IN THE AL AKSA MOSQUE HAVE BECOME INVOLVED IN STONE-THROWING DEMONSTRATIONS OF A NATIONALIST CHARACTER IN THE OLD CITY, AND CHRISTIAN MISSIGN-ARIES SEEKING OUT JEWISH AND OFTEN EVEN MCSLEM SCULS TO CAPTURE, AND FANATICAL JEWISH CROUPS SETTING FIRE TO THRISTIAN INSTITUTIONS, SETTING BOMBS, BREAKING WINDOWS AND DURNING MISSICNARY, LITERATURE. CNE SUCH GROUP IS CALLED "PEILIM" (ACTIVISTS). THEY PUBLISH LISTS OF CHRISTIAN ORGANIZATIONS...WITH OUTCRIES (WHICH OFTEN LEADS TO DISTURBANCES). THEY DO NOT SEE THEMSELVES AS BEING ANTICHRISTIAN, BUT ONLY (OPERATE ACCORDING TO THE) PRINCIPLE CF: "BE A CHRISTIAN IN YOUR OWN HOME, BUT DO NOT SEEK TO IMPOSE YOUR BELIEF ON THE BELIEF OF CTHERS." THE JEWISH PUBLISHER SCHALOM BENCHORIN DECLARES: "ONE CAN IMAGINE IF SUCH A LAW AGAINST JEWISH ACTIVITIES WERE PASSED ABK.AD. WE W.ULD HAVE CONDEMNED IT IMMEDIATELY AS ANTISEMITIC. IN A DEMOCRACY RELIGIOUS FREEDOM CANNOT BE RESTRICTED. IN ALL DEMOCRATIC COUNTRIES OF THE WORLD THERE ARE ALWAYS ONVERSIONS WITHOUT THE STATE INTERFERING. INTERFERENCE WOULD ESPECIALLY BE CONDEMNED BY JEWS WHO ARE A MINORITY F LEVERYWHERE INCLINED TO TOLERANCE." ISRAELI LIBERALS ARE OF THE OPINION THAT THE NEW LAW REFLECTS THE STRENGTHENED POSITION OF POWER OF THE ISRAELI RELIGIOUS POLITICANS BECAUSE THE CANSERVATIVE PRIME MINISTER BEGIN REQUIRES THEIR PRESENCE IN BROADENING HIS CABINET BASE. THE PREVIOUS SCIALIST GOVERNMENTS BLOCKED PASSAGE OF BLATANT ANTIMISSION LEGISLATION. THERE WERE OTHER WAYS OF DEALING WITH MISSICNARY PROBLEMS: A REFUSAL TO PROLONG VISAS, AND COMPELLING THEM TO LEAVE THE COUNTRY. THIS HAPPENED FOR EXAMPLE WITH THE AMERICAN FUNDAMENTALIST ARNOLD BUTLER WHO IN 1972 WHO DECIDED ON YOM KIPPUR, THE HOLIEST JEWISH THE WAILING WALL, THE HOLIEST JEWISH SITE, TO SEEK TO DISTRIBUTE THE "THAT IS REALLY GOING TOO FAR," THE INTERIOR MINISTRY OFFICIALS CONCLUDED, NEW TESTAMENT. AND BUTLER WAS SWIFTLY ESCORTED. CUT OF THE COUNTRY.

BURN IN ENGLAND, YOUNG JOAN WENT TO INDIA TO JOIN HER FATHER, " WHI WAS IN THE BENGAL LANCERS. HER FATHER ENDED UP A GENERAL & JOAN RETURNED HOME AT THE TIGE OF EIGHT. MARKIED TO AN ANGLICAN CLERGYMAN MIGHT HAVE LED TO A QUIETER LIFE. BUT SHE AND HER HUSBAND TOOK A CAMEL TRIP THRO! THE AUSTRALIAN OUTBACK WHERE THEY MET WITH ABORIGINES WHO HAD NEVER SEEN A WHITE WOMAN PEFCHE. THEY ALSO SPENT TIME IN FIJI...MRS. MC WHIRTER'S FIRST CONTACT WITH ISRAEL CAME DURING A PORTNIGHT CHURCH TOUR OF THE COUNTRY IN MARCH 1973. SHE SAYS SHE FELL IN LOVE WITH THE COUNTRY THEN. WHEN THE YOM KIPPUR WAR BROKE

OUT SHE IMMEDIATELY VOLUNTEERED-ONLY TO BE TOLD THE COUNTRY WANTED YOUNGER AND STURDIER VOLUNTEERS. BUT SHE MADE IT BACK HERE A FEW MONTHS LATER WITH HER HUSBAND, SETTLING FIRST ON THE MOUNT OF CLIVES AND THEN IN ELZARIYA (BETHANY). LIVING IN A LARGE RENTED FLAT, SHE SAYS SHE GETS ALONG WELL WITH HER ARAP NEIGHBOURS, ALTHOUGH SHE OFTEN ARGUES WITH THEM ABOUT ISRAEL. ON THAT SUBJECT SHE DESCRIBES THEM AS "IMMUNE TO REASON". HER TIME IS SPENT AS A VCLUNTEER IN THE HENRIETTA SZCLD ARCHIVES, FILING THE PAPERS OF THE AMERICAN ZIGNIST LEADER, AND LEARNING HEBREW THREE TIMES A WEEK AT AN ULFAN. WHEN SHE GOES BACK TO ENGLAND, IT IS AS A LECTURER TO PROMOTE ISHAEL'S CAUSE. DURING HER LAST VISIT OF 32 WEEKS MRS MC WHIRTER GAVE 39 LECTURES, FIVE RADIO TALKS, AND WAS INTERVIEWED BY FOUR OR FIVE NEWSPAPERS. RECENTLY SHE HAS BEGUN A NEW PROJECT, INTERVIEWING BRITISH CLIM AND SENDING THE STURIES TO LOCAL PAP-ERS IN THE U.K. HER HUSBAND'S COUSIN, EDITOR ROSS MC WHIRTER, WAS THE VICTIM OF E TERROR WHEN IRA GUNNEN SHOT HIM CUTSIDE HIS LONDON HOME A FEW YEARS AGO. FEELING THEY WOULD LIKE TO HAVE A MEMORIAL SERVICE FOR HIM IN JERUSALEM, THE MC WHIRTERS WENT TO THE CHURCH OF SCOTLAND, THEIR COUSIN'S DEMOMINATION, THE CHURCH FLDERS WOULD NOT LET THEM USE THE CHURCH, SHE SAID, FOR FEAR OF PLC REPRISALS. FINALLY, SHE NOTES HAPPILY, THE FRANCISCANS VERY GEN-ERCUSLY ALLOWED THEM TO USE THE HUMAN CATHOLIC CHAPEL IN THE CHURCH OF THE HOLY SEPULCHRE FOR WHAT TO HER KNOWLEDGE WAS THE FIRST PROTESTANT SERVICE EVER HELD IN THE HIS TORIC EDIFICE "
