AND ANY ONE CONVICTED OF CONVERTING TO ANOTHER FAITH FOR NONSPIRITUAL BENEFIT MAY SPEND THREE YEARS BEHIND BARS. EXPLAINING HIS COUNTRY'S FIRST ANTIMISSIONARY LAW, ORTHODOX MK MEIR ABRAMOWICZ, THE BILL'S SPONSOR, SAYS: "WE ARE THE REMMANT OF MILLIONS (F JEWS FROM THE PAST. WE MERELY WANT TO PROTECT OUR CHILDREN." BUT ISRAEL'S 80,000 CHRISTIANS-NOT TO MENTION MANY OF ABRAMOWICZ'S FELLOW JEWS WHO ARE CONCERNED ABOUT CIVIL RIGHTS, AMERICAN GOOD WILL & HELIGIOUS HARMONY -- THINK THE NEW BILL IS REPRESSIVE AND BADLY WRITTEN, ILL-TIMED & ILL-ADVISED. THE WORST PROBLEM LIES IN THE BILL'S TEXT. TIANS POINT OUT THAT THEY COULD CONCEIVABLY BE CONVICTED OF OFFERING "MATERIAL INDUCEMENT" IF A RECENTLY CONVERTED JEW MADE USE OF CHRISTIAN HUN SCHOOLS OR HOSPITAL SERVICES. ONE SPOKES-MAN ADDS THAT THE BILL'S SUGGESTION THAT WELL-HEELED CHRISTIAN MISSIONS ENGAGE IN BRIBERY FOR SCULS IS "CALUMNY, SLANDER & LIBEL, AS WELL AS AN INCITEMENT TO HATRED." THE BILL SLIPPED THROUGH THE KNESSET TWO DAYS AFTER CHRISTMAS WHEN ATTENTION WAS FOCUSED ON MIDDLE EAST DIPLO-MACY, AND DIPLOMACY MAY IN PART EXPLAIN ITS PASSAGE. PM MENAHEM BEGIN HAD PROMISED THE TWO CRITHCDOX PARTIES IN HIS COALITION THE PASSAGE OF ANOTHER BILL ON A DIFFERENT SUBJECT, A LAW THAT WOULD REFUSE TO RECOGNIZE CONVERSIONS TO JUDAISM IN ISRAEL EXCEPT UNDER ORTHODOX AUSPICES BUT BEGIN HAS SO FAR NOT DELIVERED ON THAT PROMISE, PERHAES OUT OF FEAR THAT LIBERAL U.S.JEWS WOULD RESENT IT. HE MAY HAVE HOPED TO GIVE THE ANTIMISSIONARY BILL TO THE ORTHODOX PARTIES AS A CONSULATION PRIZE. SHORING UP THEIR SUPPORT DURING THE NEGOTIATIONS WITH EGYPT ABOUT THE FUTURE OF THE WEST BANK, AN ISSUE ON WHICH MOST ORTHODOX JEWS TAKE A HARD LINE. IF SC, THE TACTIC IS DUBICUS: THE BILL COULD COST ISRAEL SOME OF THE STRONG SUPPORT IT NOW HAS FROM U.S. CHRISTIANS. INDEED, CHRISTIAN GROUPS IN ISRAEL ARE ALREADY ORGANIZING TO REPEAL THE LAW BEFORE IT TAKES EFFECT. CHURCH LEADERS WILL MEET NEXT WEEK WITH DAVID GLASS, CHAIRMAN OF THE KNESSET IAW COMMITTEE. THEY ARE BUCYED BY THE CUTCOME OF A SIMILAR THREAT IN ECYPT LAST YEAR WHEN ANWAR SADAT WAS FACING PRESSURE FROM MUSLIM MILITANTS FOR A LAW MAKING APOSTASY A CAPITAL CRIME FOR MUSLIMS. ECYPTIAN CHRISTIANS RAISED SUCH AN OUTCRY THAT SADAT MALE SURE THE BILL WAS DEFEATED." UNQUETE

ERIC MILES SUMMARY & EXCERPT: THIS IS A BACKGROUND ARTICLE ABOUT THE AJC, FOUNDED IN 1906 FOLLOWING KISHINEV POGROMS, ITS UNDERLYING PRINCIPLE TO FIGHT FOR EQUAL RIGHTS FOR ALL, ITS RELIEF & RESCUE OPERATIONS AT THE BEGINNING, DEVELOPING INTO AN ORGZATION OF SOME EIGHTY CHAPTERS, 40,000 MEMBERS IN OVER 600 U.S. COMMUNITIES PLUS AN OVERSEAS SERVICE IN THREE CONTINENTS, INCLUDING JERUSALEM OFFICE ESTABLISHED 1961, ITS PROGRAM OF DEVELOPING INTERGROUP RELATIONS AND EDUCATION, AN INSTITUTE OF HUMAN RELATIONS WITH STAFF OF OVER 150 PROFESSIONALS, AND ITS CURRENT INITIATIVE IN CLARIFYING THE RECENT CONTROVERSY SURROUNDING THE SOCALLED ANTIMISSION-ARY LAW AMENDMENTS TO ISRAEL'S _ CRIMINAL CODE. THE LEGISLATION SPARKED A FLURRY OF CON-CEHN AMONG CHRISTIAN GROUPS AROUND THE WORLD. THE AJC'S HQ IN NEW YORK RECEIVED A SERIES OF REPORTS DESCRIBING THE RESPONSES OF INTERNATIONAL CHRISTIAN AND INTERFAITH GROUPS. COMMITTEE ANALYSTS CONCLUDED THAT THESE REACTIONS INDICATED THE EXISTENCE OF A SERIOUS PROBLEM FOR CH-RISTIAN JEWISH RELATIONS IN THE DIASPORA. ACCORDINGLY, AJC PRES. RICHARD MAAS WROTE TO PM MENAHEM BEGIN & JUSTICE MIN SHMUEL TAMIR DRAWING THEIR ATTENTION TO THE DISTRESS FELT BY CHRISTIAN LEADERS, PARTICULARLY AMONG THOSE WHO HAVE BEEN ISRAEL'S STAUNCHEST SUPPORTERS. AT THE SAME TIME, DR BERNARD RESNIKOFF, DIRECTOR OF THE AJC'S ISRAEL OFFICE IN JERUSALEM, ARRANGED A SMRIES OF CONSULTATIONS FOR CHRISTIAN LEADERS WITH DR DAVID GLASS, CHAIRMAN OF THE LAW COMMITTEE. SUBSEQUENTLY DR RESNIKOFF ESCORTED A SEVEN MAN DELEGATION OF THE UCCI TO A TWO HOUR CONFERENCE WITH SENIOR OFFICIALS IN THE MINISTRY OF JUSTICE. THE RESULT OF THE AJC INITIATIVE WAS A FOUR PAGE LETTER TO PRES MAASS FROM JUSTICE MIN TAMIR WHICH GAVE AS-SUHANCES THAT THE LEGISLATION IS NOT INTENDED IN ANY WAY TO RESTRICT THE CHRISTIAN COMMUNITY'S RELIGIOUS FREEDOM IN ISRAEL. TAMIR REAFFIRMED THE GOVT'S COMMITMENT TO UPHOLD THE FUNDAMENTAL PRINCIPLES OF THE RIGHT TO FREEDOM OF RELIGION AND CONSCIENCE, INCLUDING THE RIGHT TO CHANGE HELIGION OR BELIEF. THE LEGISLATION PROHIBITS THE CIVING OF MONEY CROCTHER MATERIAL BENEFITS TO ANYONE IN ORDER TO INDUCE A CHANGE IN RELIGION. IT PROVIDES FOR FIVE YEARS IMPRISONMENT OR A FINE OF IL50,000. IN HIS LETTER TO MK MAASS THE JUSTICE MIN EXPLAINED THAT THE LAW IS NOT DESIGNED TO IMPEDE THE CHRISTIAN OR ANY OTHER COMMUNITY "FROM THE PURSUIT OF NORMAL EDU-CATI NAL OR PHILANTHROPIC ACTIVITIES." HE ALSO POINTED OUT THAT IN THE FINAL ANALYSIS THE

INTERPRETATION OF THE LAW IS A MATTER FOR THE ISRAELI COURTS, WHOSE INDEPENDENCE & REPUTATION

URING THE CONFERENCE ARRANGED BY DR RESNIKOFF FOR LOCAL CHRISTIAN LEALERS AND GOVT OFFICIALS IT WAS AGREED THAT THE TWO SIDES WILL MEET AGAIN WITHIN A FEW MONTHS TO JOINTLY ASSESS THE RESULTS OF THE LAW. BUT HAS ANYONE CONSIDERED BRINGING THE JEWISH AGENCY TO COURT? HAS ANYONE CONSIDERED BRINGING TO COURT THE ARMY BECAUSE IN CERTAIN UNITS, IN FIELD, SECURITY O WINCE, TIES NO PERSON WILL BE ACCEPTED UNLESS HE DECLARES HIMS ELF TO BE A RELIGIOUS JEW. THIS IS EXACTLY WHAT THE PERSONAL QUESTIONNAIRE REQUIRES. A RELIGIOUS MARK FOR THE RECRUIT, OF HIS NEXT OF KIN AND OF THOSE WHO RECOMMEND HIM. HAS ANYONE CONSIDERED BRINGING THE STATE OF ISRAEL AND THE KNESSET OF ISRAEL TO COURT FOR DETERMINING THAT CHILDREN OF MIXED MARRIAGES WHO CAME TO US ACCORDING TO THE LAW OF RETURN FROM ROMANIA, RUSSIA, POLAND, THE USA, ARE UNABLE TO WED, TO REAR A FAMILY, TO OBTAIN RIGHTS TO A FLAT, ETC ETC, EXCEPT IF THEY FIRST CONVERT TO JUDA-ISM? IS THIS NOT ENTICEMENT TO CONVERSION IN EXCHANGE FOR MATERIAL BENEFITS? ON THE OTHER HAND, NOT A SINGLE PROOF WAS BROUGHT BEFORE THE KNESSET, IN PLENUM OR IN COMMITTEE. OF EN-TICEMENT OF THIS KIND, OR RESEMBLING IT, BY ANY CHRISTIAN CHURCH. WE ALL KNOW THE THUTH. WE ALL REPRESS IT. HE ALSO FOUNDED A RESIDENCE FOR JEWISH CONVERTS. ALSO A DESCRIPTION OF SCHNELLER, A GERMAN/CHRISTIAN, WHO WORKED AMONG THE EASTERN CHURCHES, ALSO FOUNDED AN ORPHANAGE FOR VICTIMS OF THE MASSACRE OF CHRISTIANS IN LEBANON, A SCHOOL FOR THE BLIND, A PRINTING PLANT, A BRICK FACTORY, ETC ETC A JEWISH CONVERT FAUL BERGHEIM BECAME A SUCCESSFUL BANKER AND WINE DEALER, ALSO DEVELOPED A MILL HUN BY STEAM FOR GRINDING FLOUR. "THE JEWS CALLED IT BERHEIM'S MEAL (FLOUR IN YIDDISH), NEVERTHELESS, ACCORDING TO JEWISH LAW BERGHEIM WAS A JEW AND HIS LAND WAS THE LAND OF JEWS—HE WAS THERE—FORE LIABLE TO THE (RELIGIOUS) LAWS OF OFFERINGS AND TITHES FROM HIS PRODUCE."
