OF THE SECT MEMBERS HAD ASSEMBLED YESTERDAY MORNING FOR PRAYER IN A PRIVATE HOUSE IN THE
SHIKUN HAMIZRAH IN RISHON LETZION. A SHORT TIME AFTER THE COMMENCEMENT OF WORSHIP, ULTRAORTHODOX JEWS ARRIVED AT THE PLACE, WHO WERE RESIDENTS OF A NEARBY NEIGHBOURHOOD. THE
ULTRA-ORTHODOX BEGAN TO CONDUCT GROUP PRAYER IN THE FRONT OF THE HOUSE, AND AFTERWARDS
COMMENCED DANCING. THE SECT MEMBERS DID NOT DISCONTINUE THEIR WORSHIP, AND SEVERAL OF
THE ULTRAORTHODOX ENTERED INTO THE HOUSE, IN THE COURSE OF WHICH A FLOWER-POT WHICH
STOOD ON THE PORCH WAS BROKEN. TEMPERS FLARED, AND THERE FOLLOWED A SHARP EXCHANGE OF
WORDS (BETWEEN THE TWO GROUPS). NEIGHBOURS CALLED THE POLICE, AND A POLICE FORCE ARRIVING ON THE SEENE PACIFIED THE SITUATION: UNQUOTE

NO ONE WAS ARRESTED BECAUSE OF THE SANCTITY OF THE SABBATH, BUT SEVERAL OF THE ULTRAORTHODOX WERE INVITED TO APPEAR TODAY FOR POLICE INVESTIGATION. UNQUOTE

QUOTE : THE PUBLIC RELATIONS COMMITTES OF THE UCCI YESTERDAY PROTESTED THE ATTACK AGAINST "MESSIANIC JEWS" WHICH WAS CONDUCTED LAST SABBATH IN RISHON LETZION. THE PRO-TEST WAS SOUNDED AT A PRESS CONFERENCE IN TELAVIV AT BEIT SOKOLOW. REVEREND ROY KREIDER, REPRESENTING THE UNITED ALLIANCE OF MESSIANISTS IN ISRAEL AND THE LIAISON COMMITTEE OF THE ALLIANCE, PRESENTED A LETTER WRITTEN IN ENGLISH WHICH HAD BEEN SENT BY THE ALLIANCE TO THE PRESIDENT OF THE STATE OF ISRAEL, IN WHICH THERE WAS A PHOTEST ABOUT THE ATTACK IN RISHON LETZION. IN THE LETTER TO THE PRESEDENT IT WAS STATED, AMONG OTHER THINGS, THAT IN AN APPEAL MADE TO THE PREVIOUS PRESIDENT ON 29 DECEMBER OF LAST YEAR IT HAD BEEN STATED THAT THE LAW AGAINST RELIGIOUS ENTICEMENT WAS LIABLE TO ENDANGER SMALL COMMUNITIES WHICH CANNOT DEFEND THEMSELVES. IT WAS FURTHER STATED THAT WITHIN THE PAST SIX MONTHS SINCE THE PASSAGE OF THE LAW IN THE KNESSET, THERE HAVE OCCURRED INCIDENTS IN JERUSALEM, TELAVIV, TWICE IN JAFFA, IN HAIFA, IN NAHARIYA, AND RECENTLY IN RISHON LETZION. REVEREND HENRY KNIGHT, WHO WAS BORN A JEW, DECLARED THAT THE MESSIANIC ALLI-ANCE UNITES WITHIN IT TWENTY MESSIANIC COMMUNITIES (PROTESTANT) IN ISRAEL AS WELL AS OTHER CHURCHES AND INSTITUTIONS. HE CLAIMS THAT MESSIANIC JEWS ARE JEWS, ALTHOUGH THERE ARE MESSIANISTS WHO ARE NOT JEWS. THE MESSIANISTS BELIEVE ALSO IN THE NEW TESTAMENT. THE MESSIANISTS IN ISRAEL HAVE SMALL GROUPS WHICH MEET IN PRIVATE HOMES FOR WORSHIP. IN RISHON LETZION AND THE GENERAL AREA THERE ARE ABOUT THIRTY MESSIANISTS, INCLUDING WOMEN AND CHILDREN. REVEREND ARTHUR GOLDBERG, REVEREND BARUCH MAOZ, AND ONE PERSON WHO IDENTIFIED HIMSELF BY A PSEUDONYM (DANNY OREN), ALL OF RISHON LETZION, RELATED THAT ON SHABBAT MORNING, 17TH JUNE, THE HOME OF THE GOLDBERG FAMILY WAS BROKEN INTO BY AN ANGRY MOB OF 150-200 PERSONS. IN THIS HOUSE THE MESSIANIC JEWS ASSEMBLE FOR WORSHIP. THE CROWD MADE AN OUTCRY AGAINST THE PERSONS WITHIN THE HOUSE AND EVEN ATTACKED THEM: AFTER FIVE HOURS A POLICEMAN CAME AND THE ATTACKERS DISPERSED. UNQUOTE

QUOTE: THE PUBLIC RELATIONS COMMITTEE OF THE UCCI PROTESTED TO THE PRESIDENT OF THE STATE OF ISRAEL, YITZHAK NAVON AGAINST THE ATTACK ON MESSIANIC JEWS WHO WERE WORSHIPPING ON SHABBAT IN A PRIVATE HOME IN RISHON LETZION, AT THE HANDS OF EXTREMIST RELIGIOUS SEMINARIANS, AND CHARGED THAT THE INCREASING VIOLENCE IS THE RESULT OF THE "MISSION LAW". AT A PRESS CONFERENCE YESTERDAY IN BHIT SOKOLOW IN T.A. ARTHUR GOLDBERG, OWNER OF THE HOUSE AT 407 HARAKEFET IN RISHON LETZION, AND REVEREND BARUCH MAOZ, RELATED THAT ON SHABBAT THE SEMINARIAN THE SEMINARIAN STATESTED TO THE HOUSE OF THE SEMINARIAN STATESTED.

FISTS, SHOUTED ABUSE AND THREATS, OVERTURNED A TABLE, THREW DOWN AND TORE HOLY SCRIPTURE, AND THREW A FLOWERPOT TO THE FLOOR, AND ALSO STRUCK THE MISTRESS OF THE HOUSE AND ONE OF THE GUESTS. AN AUTOMOBILE WHICH HAD BROUGHT ANOTHER GUEST TO THE HOUSE, A BLIND TOURIST FROM ABROAD, WAS ATTACKED, AND THE MOB THREATENED TO SET IT AFIRE. THE SPOKESMEN SAID THAT THE LEADERS OF THE RIOTING MOB WERE TWO RABBIS, WHO ABUSED THEM BE-CAUSE OF THEIR BELIEF AND THREATENED TO DRIVE THEM OUT OF TOWN AND TO HANG THEM ON AN ELECTRIC POLE. THE HARASSMENTS CONTINUED AT NIGHT BY TELEPHONE. THE SPOKESMEN ALSO SAID THAT THE RELIGIOUS EXTREMISTS WERE INCITING THE RESIDENTS OF THE NEIGHBOURHOOD AGAINST THEM AND THREETENING THEIR CHILDREN. THE POLICE, WHO HAD BEEN CALLED BY TELEPHONE WHEN THE ATTACK BEGAN, SENT A LONE POLICEMAN TO THE SCENE, AFTER FIVE HOURS. ON THE MORROW GOLDBERG MET WITH THE COMMANDER OF THE POLICE STATION IN HISHON LETZION AND, ACCORDING TO HIM, HE WAS TOLD THAT THE POLICE WOULD NOT . PRESS CHARGES AGAINST THE RIOTERS. IN REPLY TO A QUESTION BY THE CORRESPONDENT OF TAVAR", THE COMMANDER OF THE CENTRAL POLICE DISTRICT, LT. COM. ENOSH GIVATI, SAID THAT THE POLICEMAN ARRIVED AT THE HOME OF GOLDBERG AT 11.00 A.M., A SHORT WHILE AFTER THE COMPLAINT WAS RECEIVED AT THE POLICE, AND THAT AFTERWARDS POLICEMEN WERE SENT TO THE SCENE AS REINFORCEMENTS. FOUR OF THE ATTACKERS WERE DETAINED AND THE POLICE WILL SUBMIT CHARGES AGAINST THEM TO THE COURT. ACCORDING TO HIM, GOLDBERG COMPLAINED OF THE BREAKING OF ONLY ONE FLOWERPOT. UNQUOTE

QUOTE : WHILST WE CAN SYMPATHIZE WITH RABBI DOLGIN'S SENSE OF FRUSTRATION AND HIS THEO-LOGICAL DISAGREEMENTS WITH THE GROWING NUMBER OF HEBREW-CHRISTIANS IN ISRAEL (MAY 7), HIS SENSE OF GRIEVANCE, HOWEVER JUSTIFIED, LEADS HIM TO DANGEROUS AND APPALLING CONCLUSIONS. FORTUNATELY FOR US MORTALS, THE GRANTING OF "SALVATION OF THE WORLD TO COME" IS THE PRO-VINCE OF THE MERCIFUL AND ALMIGHTY, NOT OF RELIGIOUS PROFESSIONALS OF ANY KIND. BUT WHEN RELIGIOUS ACTS OF DISSENT FROM AN "ORTHODOX" POSITION ARE DUBBED AS NATIONAL "TREACHERY", "LEAVING ONE'S PEOPLE" RESULTING IN "LOSING RIGHTS, " A "BETRAYAL WHICH CANNOT BE TOLERATED ANYWHERE" AND WHICH THEREFORE CANCELS OUT THE APPLICABILITY OF THE UNIVERSAL DECLARATION OF HUMAN RIGHTS, RABBI DOLGIN AND THOSE WHO PROPAGATE SUCH IDEAS ARE ON DANGEROUS QUICK-SANDS WHICH COULD SWALLOW UP MORE THAN THE IMMEDIATE OBJECTS OF CONTEMPT. RABBI DOLGIN'S CALL TO USE THE CIVIL ARM OF THE STATE AS A WEAPON AGAINST RELIGIOUS OPPONENTS WOULD NOT BE TOLERATED BY JEWS ANYWHERE ELSE IN THE WORLD, ESPECIALLY IN THE PREVAILING MOOD TO RE-ASSESS HECENT HISTORY. WHAT'S SAUCE FOR THE GOOSE IS SAUCE FOR THE GANDER. THE CHUEL LOGIC OF RABBI DOLGIN'S POSITION IS THAT, IF RUSSIA SEES JEWS OR CHRISTIANS AS "ENEMIES OF THE PEOPLE" FOR IDEOLOGICAL REASONS, THEN IT HAS THE RIGHT TO LEGISLATE AGAINST THESE DISLOYAL HUSSIANX, JEWS HAVE SUFFERED FROM PRECISELY THESE DOUBLE-THINK STANDARDS DOWN

E CENTURIES AND HAVE ONLY RECENTLY EMERG ED FROM THEIR WORST MANIFESTATIONS IN NAZI EUROPE. LAWS BANNING THE DISSEMINATION OF RELIGIOUS VIEWS CONTHARY TO THOSE OF THE RE-LIGIOUS ESTABLISHMENT WOULD, IN RABBI DOLGIN'S VIEW, BE ENTIRELY JUSTIFIED IN ISRAEL. AND HOW ARE THE PUBLIC SUPPOSED TO REACT TO THESE "OPPONENTS, IF NOT ENEMIES?" IS NOT THIS A FURTHER SERIOUS INCITEMENT, THAT HAS BEEN INCREASING IN INTENSITY OVER THE PAST 30 YEARS, TO HARASSMENT AND THREATS AGAINST THIS TINY MINORITY? HAVE NOT SUCH NEGATIVE STANCES BEEN GIVEN A SEMBLANCE OF LEGITIMACY BY RELIGIOUS INTEREST GROUPS DEMANDING AND JUSTIFYING THE SOCALLED "ANTIMISSION LAW"-A LAW REQUESTED ON THE BASIS OF UNSUBSTANTIATED ALLECATIONS OF THE MOST SERIOUS KIND, WHERE THE ACCUSERS ALSO ACTED AS THE JUDGE, AND PASSED THE LAW WITH ONLY ONE THIRD OF THE KNESSET PRESENT AT A CRITICAL POLITICAL MOMENT? THIS LAW MAY YET PROVE TO BE A POLITICAL BLUNDER OF SERIOUS PROPORTIONS WITH FOREBODING SIGNIFICANCE FOR THE QUALITY OF LIFE AND FREEDOM OF CONSCIENCE IN ISRAEL. THE GOVT AT HOFE AND THE FOREIGN MINISTRY ABROAD HAVE GIVEN RENEWED ASSURANCES THAT ISRAEL WILL HON-OUR ITS INTERNAL AND INTERNATIONAL OBLIGATIONS ON HUMAN RIGHTS, INCLUDING THE RIGHT TO CHANGE ONE'S RELIGIOUS BELIEF AND TO EXPRESS THAT BELIEF OPENLY. ARE THESE ASSURANCES TO BE TAKEN SERIOUSLY, IN PRACTIC!, NOT LIP SERVICE, RABBI DOLGIN? IF SO, THEN SOCIAL, CIVIL OR RELIGIOUS DISABILITIES SHOULD NOT FOLLOW TREOLOGICAL OR IDEOLOGICAL DIFFERENCES OF BELIEF OF LOYAL CITIZENS, BE THEY ORTHODOX, REFORM, CONSERVATIVE, MESSIANIC OR SECULAR JEWS. PERHAPS THE AUTHORITATIVE EVEN SHOSHAN HEBREW DICTIONARY (LATEST EDITION, p.1556) COULD HAVE A SAY HERE. MESSIANIC JEWS (HEBREW CHRISTIANS) ARE DEFINED AS: " .. A SECT OF JEWS THAT DECLARE THEMSELVES TO BE JEWS IN THEIR NATIONHOOD, LOYAL TO THE STATE OF ISRAEL AND CHRISTIANS IN THEIR RELIGIOUS BELIEF." THAT DEFINITION IS ACCURATE OF MOST, IF NOT ALL, HEBREW CHRISTIANS KNOWN TO US. TO CALL THEM "ENEMIES OF THE PEOPLE" IS RABBI DOIGIN'S FANTASY. SURELY MEN OF GOODWILL CAN DO BETTER THAN THAT. THIS IS A TIME FOR UNITING, NOT DIVIDING. UNQUOTE

GIVING A BRIBE TO INDUCE CONVERSION CAN LAND A MISSIONARY IN JAIL FOR FIVE YEARS, AND THE PERSON WHO ACCEPTS SUCH BRIBE CAN GET THREE YEARS. IN VOTING FOR THE NEW LAW MK BENJAMIN HALEVY, A FORMER JUSTICE OF THE SUPREME COURT, DECLARED THAT THE ISSUE IS NOT RELIGIOUS DISCRIMINATION, BUT BRIBERY. "JUST AS BRIBERY IS ABHORRENT IN JUSTICE AND EVERYDAY LIFE, SO IT IS ABHORIGENT IN ATTEMPTING TO INFLUENCE SOMEONE TO CHANGE HIS RE-LIGIOUS CONVICTIONS." HE POINTED OUT THAT IT WOULD ALSO BE A CRIDE FOR A JEW TO OFFER COMPENSATION FOR A CHRISTIAN TO CONVERT. IT IS NO SECRET THAT THE SPONSORS OF THE BILL WERE ORTHODOX JEWS WHO HAD BECOME ALARMED AT THE GROWING ACTIVITY OF CHRISTIAN MISSION-ARIES. ACCORDING TO FIGURES PRESENTED, THERE ARE MORE THAN 30 MISSIONARY ORGANIZATIONS AND 70 INSTITUTIONS OPERATING IN ISRAEL SEEKING JEWISH SOULS. THEY ARE ACTIVE IN SLUM NEIGHBOURHOODS AND ALONG NEW IMMIGRANTS WHO FIND INTEGRATION DIFFICULT. THEY ARE SAID TO OFFER NEW APARTMENTS, HELP WITH EDUCATION, AND EVEN AID IN EMIGRATING FROM ISRAEL. FOR THE MOST PART, THEY ARE SMALL FRINGE DENOMINATIONS. THE ROMAN CATHOLICS, FOR EX-AMPLE, DO NO MISSIONARY WORK AT ALL. REACTIONS TO THE NEW LAW HAVE BEEN MIXED. THE POPULAR AFTERNOON PAPER "MAARIV" QUERIED WHY IT WAS NECESSARY TO PROTECT DROPOUTS. WHO WANTS THEM? IF THEY FUT A PRICE ON THEIR JUDAISM, LET THEM GO. BESIDES, SAID MAARIV. IT'S NOT ONLY THE POOR WHO HAVE A PRICE FOR THEIR RELIGION. IN OUR HISTORY WE HAVE HAD JEWS WHO WERE "BOUGHT" FOR A SEAT IN PARLIAMENT, FOR A POSITION IN A UNIVERSITY, FOR A PLACE IN INDUSTRY. LET THEM GO! OTHER COMMENTS: WHY THE BIG FUSS? FAR MORE NON-JEWS CONVERT TO JUDAISM EVERY YEAR IN ISRAEL THAN THE REVERSE... THE WAY TO STOP SALE OF RE-LIGIOUS LOYALTY BECAUSE OF PHYSICAL NEED IS TO TACKLE THE SOCIAL PROBLEMS WHICH CAUSE THOSE NEEDS, NOT ENACT LEGISLATION...SECULARISTS HAVE ATTACKED THE NEW LAW AS "PERSECU-TION OF CHRISTIANS" AND SUGGEST THAT SEVERE PUNISHMENT BE INFLICTED ON ANYONE FOUND GUIL-TY OF INDUCING PEOPLE TO PRACTICE RELIGION. THES ECULA RISTS ALSO DEMAND "PHOTECTION" AGAINST THE ACTIVITIES OF THE LUBAVITCH EMISSARIES WHO SEEK, NOT TO CHANGE A PERSON'S RELIGION, BUT TO EFFECT CHANGE IN HIS WAY OF LIFE...A CHRISTIAN SPOKESMAN IS DISTURBED THAT THE LAW OFFERS OPPORTUNITY FOR PROVOCATEURS TO TRAP DEVOUT CHRISTIANS AND ACCUSE THEM OF BRIBERY IF THEY BEFRIEND PEOPLE. ANOTHER CHRISTIAN: WE ABHOR UNDERHANDED METH-ODS FOR CONVERSION. ANYONE WHO BECOMES A CHRISTIAN FOR FINANCIAL GAIN IS NOT THULY A CHRISTIAN. BUT YOU MUST RECOGNIZE THAT IF WE TRULY BELIEVE OUR FAITH THE TRUE ONE, OFFER-ING SALVATION TO ALL HUMAN BEINGS, IT IS INCUMBENT UPON US TO BRING IT TO THE ATTENTION OF OTHERS AND SEEK TO CONVINCE THEM OF ITS WORTH-BUT CERTAINLY NOT BY BRIBERY. AND RABBI YEHUDA MEIR ABRAMOVITZ, WHO INITIATED THE BILL: IF IT IS A CRIME TO INFLUENCE THE OUTCOME OF A SOCCER GAME BY VARIOUS FORMS OF "PERSUASION", IT IS NO LESS REPREHENSIBLE TO PERSUADE A MAN TO CHANGE HIS RELIGION BY OFFERING HIM MONEY AND A TICKET OUT OF ISRAEL.

QUOTE : TELAVIV: ISRAEL'S NEW LAW MAKING IT AN OFFENSE TO INDULGE IN MISSIONARY ACTIVITY HAS CAUSED INCREASED REACTION FROM NONJEWISH RELIGIOUS GROUPS SINCE THE AMENDMENT TO THE PENAL CODE WAS ADOPTED LAST DECEMBER. THE LAW CALLS FOR PENALTIES OF FIVE YEARS IN PRISON UPON CONVICTION FOR ANYONE OFFERING MATERIAL INDUCEMENTS TO CHANGE THEIR RELIGION. ACCEPTING SUCH A MATERIAL BENEFIT IS PUNISHABLE BY THREE YEARS JAIL. THE UCCI, AN UMBRELLA ORGANIZATION OF PROTESTANT CHURCHES AND AGENCIES, HAS BEEN CAMPAIGNING FOR REPEAL OF THE AMENDMENT, WHICH IS REGARDED AS THE START OF A MOVE TO RESTRICT THE CHRISTIANS WHO NUMBER 5,000 to 6,000. THE MEASURE DOES NOT SPECIFY CHRISTIANS. ITS SPONSOR, RABBI YM EBRAMOWITZ OF THE ULTRAORTHODOX AGUDAT YISRAEL PARTY, HAS ACKNOWLEDGED THAT WHILE HE WANTED A LAW PROKIBITING CHRISTIAN PROSELYTIZING, HE SETTLED FOR THE LIMITED LEGISLATION BECAUSE HE FELT PARLIAMENT WOULD NOT PASS A MORE SWEEPING ONE. THE UCCI, WHICH INCLUDES ANGLICANS, BAPTISTS, LUTHERANS & PRESBYTERIANS, HAS PROTESTED THE LAW IN TELEGRAMS & PETITIONS. LAST WEEK IT ADDRESSED TO ATTY GEN AHARON BARAK A MEMO URGING THAT HE INVITE AN INDEPENDENT INTERNATIONAL COMMISSION TO INVESTIGATE WHAT LED PEOPLE TO EMBRACE CHRISTIANITY, JUDAISM OR ISIAM IN ISRAEL. FR KNIGHT FORECAST THAT SUCH AN INQUIRY WOULD FIND THERE ARE PRESSURES ON PEOPLE TO CONVERT JUDAISM. ISRAELI LAW REQUIRES HO TH PA RT-NEKS IN A MARRIAGE TO BE OF THE SAME RELIGION, AND A SUBSTANTIAL NUMBER OF ISRAELIS HAVE SAID TO HAVE CHANGED THEIR FAITH TO WED. FEW JEWS BECOME CHRISTIANS, ACCORDING TO ISRAELI SOURCES, BUT 500 CHRISTIANS A YEAR CONVERT TO JUDAISM. FR KNIGHT MAINTAINED THAT IM-MIGRATION & CITIZENSHIP LAWS GAVE JEWS INTRINSIC PRIVILEGES THAT MIGHT BE CONSTRUED AS INCENTIVES TO CONVERT. THE CHURCHMEN IN THEIR MEMO DEMANDED THAT AN APOLOGY BE DELIVERED IN PARLIAMENT FOR MUNFOUNDED ALLECATIONS & CHARDESH SAID DO MAKE DEPART TO THE TRANSPORTER

ON THE AMEN DMENT. GIDEON HAUSINER (ILP) SAID IT COULD NOT BE FORGOTTEN THAT FOR 2,000 YRS THE JEWISH COMMUNITY WAS REDUCED BY CONVERSIONS TO CHRISTIANITY, OFTEN UNDER BRUTAL CO-ERCION. BINYAMIN HALEVY (DMC) CALLED MISSIONARIES "A CANCER IN THE BOIL OF THE NATION". SOME ORTHODOX DEPUTIES CHARGED THAT MISSIONARIES "WITH UNLIMITED MEANS" HAD INCITED IS-RAELI SOLDIERS TO DESERT THEIR UNITS AND JEWS TO EMIGRATE. THE CHURCHMEN, DENYING THAT THEY EXPLOITED POVERTY, INADEQUATE HOUSING OR OTHER HIVATION TO WIN CONVERTS, REAFFIRMED A JOINT DECLARATION BY THE CHRISTIAN COMMUNITIES SAYING THAT BY DISCUSSION, TALKS &LITER-ATURE WE SEEK TO ANSWER THE INQUIRIES BY THOSE WHO DESIRE TO OBTAIN INFORMATION ABOUT CHRISTIANITY." THEY ADDED: "WE BELIEVE WE CANNOT REFUSE TO DO SO, BECAUSE WE MUST SHARE WITH EVERYONE THE LIGHT AND JOY OF OUR FAITH." THERE HAS BEEN NO OFFICIAL RESPONSE TO THE CLERGYMEN'S PROTEST, BUT YISRAEL LIPPEL, DIREC GEN OF MIN RELIG AFF, DISMISSED IT IN REPLY TO A QUERY, AS A TEMPEST IN A TEAPOT. ASSERTING THAT THE LAW WAS NOT ANTI-MISSIONARY BUT ANTI-BRIBERY, HE SAID: "CHRISTIANS CAN PREACH AND CONVERT ALL THEY WANT AS LONG AS THEY DON'T OFFER MATERIAL BENEFITS." WHILE HE ACKNOWLEDGED THAT THE ATMOSPHERE IN ISRAEL DID NOT FAVOUR LARGE SCALE CONVERSION TO CHRISTIANITY, HE OBSERVED THAT IT WAS TO THE CREDIT OF ISRAELI DEMOCRACY THAT CHRISTIANS COULD PREACH HERE AS THEY DO.
