THE FOLLOWING DAY THE COUNCIL HEAD SENT A LETTER TO THE GERMANS REQUESTING THAT THEY REFRAIN FROM SUCH ACTS IN THE FUTURE. IN RESPONSE, THE DIRECTOR OF THE HOSTEL CAME TO THE COUNCIL AND PROMISED THAT THERE WOULD BE NO REPETITION. RAV EZRIELI SAYS+ "IF AT THE CUTSET WE THOUGHT THAT THIS WAS A MISSIONARY SECT, THEN LITTLE BY LITTLE WE SENSED THAT SOMETHING WAS BEING COOKED UP THAT WAS BEYOND THE PROMULGATION OF CHRIS-TIANITY: EMA BERGER CEASED FROM HER MISSIONARY ACTIVITIES, BUT RUMOURS BEACHED US THAT A BUDGET OF HUNDREDS OF MILLIONS OF LIROT WERE AT HER DISPOSAL EACH YEAR. SHE BEGAN HER GRADUAL BUT STUBBORN EXPANSION....THEY EVEN HAD THE HUTZPA TO COME AND ASK ME TO GRANT PERMISSION TO MARKET THEIR GRAPES AT THE (LOCAL) WINEPRESS. I OPPOSED IT, AND THEY ARE PRESENTLY MARKETING THEIR PRODUCE AT THE LATRUN TRAPPIST WINEPRESS." .... EMMA BERGER ALSO CONTRIBUTED TO VARIOUS INSTITUTIONS, INCLUDING YOUTH ALIYA AND THE SOLDIERS WELFARE ORGANIZATION. WHEN THE SIX DAYS WAR BROKE OUT, EMMA BERGER WENT UP TO RAMAT HAGOLAN (GOLAN HEIGHTS) WITH THE "AUNTIES" OF THE SOLDIERS WELFARE ORGANIZATION REACHING THE FRONT LINES AND DISTRIBUTING CIFTS TO THE SOLDIERS. BUT VERY SWIFTLY THE FRIENDLY RELATIONS VANISHED AND THE ZICRON SETTLERS, EXCEPT FOR ISOLATED FEW, BECAME HOSTILE TO THE GERMANS. THEY SAW A THREAT IN THEM, A CONTINUALLY DEVELOPING MALADY. DEMONSTRATIONS AND HARASSMENTS BEGAN AND EMMA BERGER BEGAN TO ISOLATE HERSELF. USUALLY THE SHUTTERS ARE CLOSED IN HER MANY HOUSES. THEY DON'T CONVERSE WITH STRANG-ERS, ESPECIALLY NOT WITH JOURNALISTS. THE SECTARIANS CHARGE THAT THESE HAVE BLACKENED THEIR IMAGE. (END FIRST IN THE SERIES)

IN THE OFFICE OF JESSE SHIBOVSKY, HEAD OF THE LOCAL COUNCIL OF ZICKON, THERE IS A THICK FILE BEARING THE NAME OF EMMA BERGER. SINCE ENTERING INTO HIS DUTIES SHIBOVSKY HAS WORKED MUCH AND ANXIOUSLY DEALING WITH THE EXPANSION OF THE GERMAN SECT "BETHEL" IN THE SETTLEMENT. UNTIL A MONTH AGO IT WAS QUIET IN THE SETTLEMENT. FROM TIME TO TIME EMMA BEAGER WOULD SUBMIT PLANS TO THE TOWN COUNCIL FOR SETTING UP INDUS-TRIAL PLANTS, AND RESIDENCES. SHIBOVSKY APPEALED TO THE FRIME MINISTER, MK'S, INSTITU-TIONS AND PUBLIC FIGURES WITH THE REQUEST TO LIQUIDATE THIS PHENOMENON, BUT FOR THE MOST PART WAS UNANSWERED. AT THE MOST HE WOULD OBTAIN A PROMISE THAT THE MATTER WOULD BE INVESTIGATED AND AN EFFORT MADE TO FIND A SOLUTION. HOWEVER IT SEEMS THAT THE SUB-JECT HAD ALREADY BEEN INVESTIGATED BY FORMER GOV'TS AND THE PRESENT COV'T, AND IT APPEARS THAT THE HANDS OF THE AUTHORITIES ARE TIED AND IT IS NOT WITHIN ITS POWER TO ACT OR TO INTERVENE. FIRST OF ALL, EMMA BERGER IS OPERATING WITHIN THE FRAMEWORK OF THE LAW. SHE CONSULTS WITH JURISTS AND HER BUSINESS DEALS ARE PROPER. THIS IS A SENSITIVE PROBLEM AND IT IS DIFFICULT TO ACT AGAINST STRANGERS WHO WISH TO INVEST MONEY IN ISRAEL. THERE ARE THOSE WHO CLAIM THAT SHOULD ENMA BERGER BE PREVENTED FROM PURCHASING PROPERTY IN ISRAEL, IT IS LIABLE TO LEAD TO EMBAHASSING SITUATIONS ON THE INTERNATIONAL LEVEL. THERE WERE THOSE WHO HROPOSED ENACTMENT OF A LAW WHICH WOULD PREVENT STRANGERS AND THOSE WHO HAD NOT SERVED IN THE I.D.F. FROM PURCHASING PROPERTY IN ISRAEL. AS OPPOSED TO THIS, THE COUNTERCHARGE HAS BEEN MADE THAT SHOULD THIS BE EFFECTED, IT WOULD RESULT IN THE NEED TO BAR JEWS FROM THE DIASPORA TO PURCHASE PROPERTY, AND WHAT THEN WOULD OCCUR TO THE COVT POLICY OF ENCOURAGING FOREIGN INVESTMENTS? WHEN SHIBOVSKY LEARNED OF THE RECENT BUSINESS DEALS OF EMMA BERGER, HE DECIDED TO RESIGN HIS OFFICE IN PRO-TEST AGAINST WHAT HE CALLS "THE APATHY OF THE AUTHORITIES IN THE FACE OF THIS DISTURB-ING PHENOMENON," HE STATES: "WE ARE ENGAGED IN THE DEVELOPMENT OF THE SETTLEMENT AND ALONG COMES MADAME BERGER BUYING UP PROPERTY IN DEVELOPMENT AREAS.....FOR WHOM ARE WE LABOURING (IN MUNICIPAL DEVELOPMENT), FOR EMMA BERGER? THIS WOMAN LABOUR SYSTEMAT-ICALLY AND AT A PACE, SHE IS A FANATICAL WOMAN AND IT IS IMPOSSIBLE TO TALK TO HER. AGAIN AND AGAIN SHE CLAIMS THAT SHE RECEIVES HER INSTRUCTIONS DIRECT FROM GOD. AC-CORDING TO THE DEVELOPMENTS TILL NOW IT IS CLEAR TO ME THAT THE ALM HERE IS BUY UP ZICRON YAACOV. AT THIS PACE THE SETTLEMENT WILL BE GERMAN PROPERTY IN ONE GENERATION."
