QUOTE : Jerusalem city council has called for greater police protection for Christian institutions and clergymen in the city, following a rash of attacks on their property by extremist Right-wing elements believed to be linked with Rabbi Meir Kahane's Kach movement. Slogans have been daubed repeatedly on the walls of the Russian Orthodox Church and bookshops run by church groups, and church windows have been smashed. In a recent attack, Mr. Charles Cope found his Bible shop daubed with black and red paint, and with swastikas and slogans, including the words: "Missionary pigs go home:"

The secretary of the Russian Orthodox Church has reported that he and his six-year-old son have been sent threatening letters, and a number of priests have complained of being spat at and cursed by young religious Jews.

Mr. Teddy Kollek, the Mayor of Jerusalem, who is supported by the Ministry of Religious Affairs, has roundly deplored this violence, and urged the police to "deal with the perpetrators of these acts in the way they deal with the perpetrators of terrorist outrages." Mr. Menahem Begin, the Premier, said on Monday that he hoped that "these shameful attacks will end," and added that he felt sure "the police will prevent these terrible acts from being repeated."

In a letter to Mr. Kollek, Mr. David Jaeger, the liaison secretary of the UCCI, stressed the "mounting anxiety within the Christian community...caused by recently stepped up activities of anti-Christian fanatics." Mr. Jaeger specifically cited Rabbi Kahane's group, but he also mentioned other "anti-Christian" groups, believed to be a reference to anti-mission activists in the ultra-Orthodox Mea Sheartim area.


QUOTE : Jerusalem, Feb.1. - Leaders of the Christian community in Jerusalem today protested against a spate of vandalism against Christian holy sites and accused the Israeli Govt of failing to act against perpetrators. The protest, presented to Mr. Menahem Begin, the P.M., and foreign consuls in Jerusalem, as well as to the news media, said: "The impression is persistent and pervasive within the Christian community that the civil authorities have so far failed to exhaust all the possibilities open to them to curb such manifestations." It went on: "It is not infrequently said within the Christian community that the perpetrators of such acts enjoy a relative immunity."

The vandals, believed to be Jewish religious extremists who accuse the Christians of missionary activity and of profaning the Jewish character of Jerusalem, have smashed windows in a monastery, painted obscene slogans on a Christian bookshop and anti-Christian slogans on church walls, sometimes with swastika emblems, and damaged property.

The protest was signed by the Rev. Roy Kreider of the UCCI, Fr. Ignzaio Mancini, of the Christian Info. Ctr, and Fr. Bargil Pixmer of the Dormition Abbey. They represent the Roman Catholic and most of the Protestant denominations in Jerusalem. Mr. Teddy Kollek, the Mayor of Jerusalem, ordered that the city should repair all the damage at its own expense, and the police and officials of the Min. of Relig. Aff. have cooperated in a search for the perpetrators of the damage. But, despite a number of arrests, the attacks have not been stopped.

"We have discussed the possibility of providing a special police guard for the holy sites, but so far, for reasons of budgets and manpower, we have been unable to carry this out," Mrs. Rachel Drori of the Min. Relig. Aff., said. "But we reject the view that this is a sudden wave of vandalism. There have been attacks like these over the past year and before." The clergymen called an "internationally guaranteed special statute concerning the rights and liberties of the three great monotheistic faiths in Jerusalem, "Fr. Mancini said in a phone interview.

Among those detained by the police in connexion with the vandalism were members of the Kach movement led by Mr. Meir Kahane, an American-born rabbi. A spokesman for Kach, Mr. Yossi Dayan, denied that his group had carried out the vandalism, but said he supported attacks on Christian sites in Jerusalem. "It is a Jewish (MORE)



obligation to destroy graven images, "he said. "The Christians have no place in Jerusalem, which is the Jewish capital. "--AP END NEWS STORY.

QUOTE : A campaign is being waged by leaders of many of the main Christian churches represented in Jerusalem to secure new international guarantees for their position inside the city, in the rest of Israel and the occupied territories. Because of complex inter-church rivalries and fierce jealousies over access to the Holy Places, many months have been spent in private consultations aimed at securing unanimity on what type of guarantees to seek. Already private feelers have been put out to win the support of leading R.C. and Prot. churchmen in Britain. A confidential document has also been circulated to interested governments with embassies and consul ates in Israel.

A copy of the document, believed to have been Vatican-inspired, reached the "TIMES" today. In a key passage about the controversial possibility of securing international guarantees for Jerusalem, it stated: "The optimal form would be a conjunction for this purpose of several Western states with a traditional interest in (Christianity in) the Holy Land, such as Greece (for Greek Orthodox), Italy, France, Britain and the U.S., as overall guarantor of agreements in the area." The six-page & cument declared: "The present situation of the Christian churches and communities in the Holy Land is also in large part anomalous, and moreover uncertain and insecure. The whole network of treatise, agreements, concessions, and status quo type arrangements which assure these institutions a whole range of necessary liberties, rights, exemptions, etc...has no firm foundation in statutory or equivalent arrangements recognized as binding on themselves by the civil power, or powers, in the land."

Although the Vatican is known to have played a strong part behind the scenes in the new campaign to secure diplomatic initiative, it has not yet declared its hand publicly. One reason is understood to be fear of upsetting the sensibilities of the influential Greek Orthodox church which traditionally holds primacy in Jerusalem. Explaining the position, one leading R.C. churchman told me: "The whole subject is a minefield of protocol. All the main churches are anxious to be seen acting in concert and not unilaterally. Miso, we are determined to see that this b ecomes a negotiating process rather than a reversion to the 19th Century when churches here appealed to the Christian nations to impose their wills on Jews & Arabs." The churchman, who did not wish his name to be published, denied that the Christian churches were indulging in diplomatic intrigue: "There is a possibility that the Middle East peace process will soon normalize the whole politico-judicial situation in the area," he said. "It is essential that the Christian churches stake their claim before that happens."

The first public pointer to the new campaign came in a single paragraph of a 3-page interchurch statement issued here last week condemning the recent upsurge of anti-Christian violence by right-wing Jowish extremists. The signatories, who represented the R.C. and most Prot. denominations in Israel, demanded "an internationally guaranteed special statute concerning the rights and liberties of the three great monotheistic faiths in Jerusalem and throughout the Holy Land." The Israel Foreign Ministry reacted angrily, accusing the clergymen of "trying to climb on the vandalism bandwagon" in seeking international intervention on the Jerusalem issue. The city is regarded by the present Govt. as the "indivisible" capital of Israel, a point which has been made strongly to Egyptian ministers over recent weeks. A senior F.M. official responsible for dealings with the Christian diurches explained: "The position of the Israel Govt. was and is clear. A special statute could be guaranteed not to Jerusalem, but to the various holy institutions and holy shrines in it. In practice I would say that this already exists because the churches have almost complete autonomy in their affairs. END REPORT

HEADING: (TIMES LONDON)" MR. HEGIN PROMISES ISRAEL WILL PROTECT CHRISTIANS" BYLINE: From Our Own Correspondent, Jerusalem, Feb. 5th.

QUOTE : Mr. Menachem Begin, the Israeli P.M., has attempted to defuse the growing international controversy over the recent upsurge of violent attacks against Christian institutions, worshippers and holy sites in Jerusalem. In a short statee ment yesterday which was later relayed to church leaders by an official, (MORE)

Mr. Begin said: "The authorities will not tolerate acts of this kind. By the laws of Israel all faiths enjoy absolute freedom of worship, protection of their properties and freedom of access to their shrines. The Govt of Israel upholds these principles in the fullest measure just as it has always done in the past in the spirit of respect of all the faiths represented in Jerusalem. Indeed, we take pride that since the reunification of our capital city, Jerusalem has enjoyed the harmony of co-existence and mutual toleration. The authorities, therefore, will do their utmost to prevent the recurrence of such intolerable criminal acts."

No details of specific measures are being given. Among the targets have been historical buildings such as the Russian Orth. church and the Mt. Zion monastery, and bible shops which have been daubed with slogans and swastikas. The attacks are believed to be the work of extreme rightwing orthodox Jewish troups. Mr. Begin's intervention followed a well-publicized claim last week by leaders of the normally reticent Christian community that the Israeli authorities were not taking sufficient action to curb the Jewish extremists. A spokesman for the UCCI described the P.M.'s statement as reassuring. He added that its implementation would be followed "very closely." END

EXCERPTS: After the "reunification" of Jerusalem following the 1967 war, the Israeli authorities were always careful to demonstrate that under their sovereignty the interests of the three great religions were equally and fully guaranteed. This image was designed to dispute any assaults upon the annexation of East Jerusalem, but has become a little tarnished in the wake of several incidents. A series of acts of vandalism have been committed during the course of the past two weeks against institutions of the Christian churches. Considered by themselves, the incidents would appear of little importance, but their increase and their possible significance in the eyes of many representatives of Catholic and Protestant institutions justified the publication on the 31st January a communiqué concerning a state of " "unease" among the Christian community of Jerusalem at the "intensification of antichristian violence." (There follows a description of a number of the incidents...on Mt. Zion Abbey, the Russ.Orth. Church, Bible Bookshops, Christian Info. Ctr....followed by several lines about Meir Kahane and his activities.)

The communiqué, published in the name of the Christian community, was signed by representatives of the UCCI (which comprises Protestant movement s) and the Christian Info. Ctr (R.C.). It was also submitted to the three patriarchs—Latin, Greek Orthodox and Armenian. This appeal takes a particular character because, besides the facts in question, it denounces a climate. Choosing their words with care, the signatories underlined the fact that their unease was appravated by an "impression", a ccording to which the authors of the appressive acts were able to enjoy a "relative impunity," and that the attacks might be provoked by an "exclusivist conception" of the character of Jerusalem. This is certainly a way of expressing discreetly a certain disquiet (? "remise") because of the provided by the provoked over Jerusalem, and more generally, of the Israeli Govt. policy.

To date there has not yet been any official reaction. The Minister of Relig. Affairs has minimized the importance of the affair. The prosecution charges that Mr. Peleg, who is now undergoing observation at the Psychiatric Hospital in K'far Shaul, attempted to damages two shops, "HETH ZION" and "LAPID". (MORE)

In one of the incidents he broke the shop window and threw into it cotton wool and straw soaked in kerosene. When he was arrested, Peleg confessed to the charges made against him and claimed that "these are shops of missionaries trying to convert Jews, and the refore I'm fighting against them." In his cell at the Russian Compound Peleg continued his fight. He set fire to the matress in his cell and a fter the fire was extinguished and he was removed to another cell, tore out the water tap there and tried to flood the place. A police officer who tried to calm the prisoner took some blows on his face which broke his nose, so that the prisoner was also charged with assault and battery. Reuven Peleg will be brought today to court for the purpose of extending his detention until the completion of legal processes against him. END

QUOTE: I am shocked by the appeal made (Director, Bridges for Peace, J'lm)
by representatives of the Jerusalem Christian community in your edition of
Feb. 1st. As a Christian, I wish to state that I have had no part in the statement and wish to disassociate myself from it completely. It is particularly
upsetting when representatives of religious groups and countries complain today
on relatively minor issues when they were silent when that which was far worse
than vandalism was being perpetrated against Jews in Europe (1932-1945), or when
vandalism against synagogues occurs in their countries.

Since "international guarantees for the religious holy places" in one country by representatives of another country could never be made workable—there being absolutely no way they could be implemented—attacks by these and other Christian groups must be seen as no more than attempts to make Israel look bad in the eyes of the world. Vandals are everywhere and no country's government can be held responsible for their actions. Vandalism here is always by minority irresponsible groups. In the cases cited by the church groups, the government naturally agreed to put their curbing on their unusually heavy agenda in dealing with terrorists, possible war, peace, economics and other items. The "offended" should use the legal options open to them in a free society, if they wish. The better way is the way of appeal to law and quiet order, and not the way of protesting by threatening.

QUOTE: When covering vandalism against Christian property, you were not at fault (as Revd. Kreider's letter complained) in reporting that some parties making an international fuss about a few broken windows were reflecting their own hostilities against Israel. Though not personally sharing this hostility, treating it as a legitimate variation of Christian opinion, he associates with an attitude heretical against the Bible and opposed to Christian duty towards Israel. The vandals themselves do enough harm to Israel, attacking not hostile elements, but some of Israel's best Christian friends. In Israel's present peril, for either Jew or Christian to weaken her abroad undermines peace itself.

Both Jewish and Christian faiths stand on one foundation: the divine inspiration of the Bible, or they stand on nothing. In 300 explicit passages, the Bible confers unconditional ownership of the Holy Land "for ever" on the Jewish people and foretells their long bitter exile and the miracle of their return. Jeremiah prophesied 25 centuries ago that Israel's regathering in our day would eclipse the miracles of the original Exodus as a proof that God lives and is shaping history precisely according to His plan.

In his letter, Revd. Kreider's chief fallacy is his statement that boundary questions are no concern of the Christian church. Acts 17:26 says boundaries are directly God's business. Is that none of the Christian church's business? The boundaries of Israel are of specific concern, because of their prophetic significance and because the accuracy and authority of the Scriptures (on which the Christian hope depends) is directly at stake in fulfilment of God's promises to Israel. Should the Bible fail towards Israel, how should it stand for the Christians? God will not fail either! He will be faithful to His two witnesses, Jews & Christians. By the fallacy of shunning Israel's problems as "politics," instead of sharing their burden as PROPHECY, Christians have deeply failed this blind and perverse generation. Christians loyal to the Bible need urgently to repent for not making it clear to the Arab peoples that it is not just the Jews, but God Himself they are opposing in claiming His land for their possession & pride, which canonly bring on them (MORE)



Complaints have reached the Dept for the War Against the Mission in Jerusalem concerning the distribution of "Messianic" tracts in the homes of residents, the renting of flats for mission activities among children and adults. This was reported by the organization "Yad L'Akhim." Two massionaries, Geoffrey (Zifr?) Ulrich and Nancy Wiffel, rented a flat in Ramat Sharat for use as a base for their activity in the neighbourhood. In Neve Yaacov a missionary couple made house visits, while teachers have reported that the children are bringing "explanatory" material in the form of tracts to school. It has been disclosed that the source of the missionary activities is in Shivtei Yisrael Street. In East Talpiot two German women are preaching in the course of house visits. They rented a flat locally. In Ramot a flat was let to a missionary belonging to the sect "Jews for Jesus" who has also begun an information campaign. END

QUOTE : "I don't know where you got the item headlined "SHAUL MI ZRAHI KING OF HEITAR EMIGRATED TO AUSTRALIA WITH HELP OF MISSION" (21.2.80), the older brother of Shaul Mizrahi, Ali Alon, a senior officer in the Israeli Police, told me yesterday. Saul's brother responded angrily yesterday, "This wierd irresponsible report is without foundation and has greatly harmed the family and his many friends causing real distress. It's strange how hurriedly such a grave charge is published when Saul isn't in the country and can't react himself." Eli Alon added: "As his brother, in close touch with him and knowing his hesitations,/cannot justify his trip to Australia, but Saul was the father of five children, and decided to to go abroad for a period of a few years in order to set himself up financially and then return to Israel. He asked for leave from Fgged (Bus Co.). He needed no one, and certainly not the Mission. He traveled with the aid of his brother-inlaw, Eli Zohar, who lives in Perth, Australia, who financed the voyage, and helped him open a restaurant partnership with him, and also found him a 5-room flat. I'm certain that Saul will return once he's established himself. It just seems his luck wasn't with him here and he couldn't make it. Saul's children are studying at a Jewish school in Australia and wearing "kippot" (skullcaps), some thing




which they didn't do while they were in Israel. Saul also respects Jewish tradition always." An additional detail that Mizrahi's brother sought to clear up: "In the same news report there was a detail which is liable to be misleading, about Beitar Jerusalem having a game in nonor of Saul, "the returns of which were dedicated to Saul." His brother adds: "Allow me to comment that that game of honor was a friendly derby in Katamon (J'lm neighbourhood) attended by a very small crowd and the income was divided with another player of Beitar (compensation for Hayim Azoulai who had to retire because of injury). Saul's portion was about IL 4,000 only. Then I said to my brother: 'Saul, keep your self-respect and don't touch—any of this money.'"

QUOTE: The slightly tense/atmosphere reigning in the Dept for the War Against the Mission of the Activists Organization of "Yad L'Akhim", is mingled with a quiet, alongside the complex and variegated activities of the restrained Dept, which creates a strange combination of opposites which characterize this special departmen which we traced one day as observers from outside watching the course of action. The personnel of the Jerusalem dept. are a small restricted team but skilled in its work and familiar with its task. Notwithstanding the abundance of work they do not lose their cool. With satisfaction and poise they deal with the many appeals, whether phoned itn or made personally, which reach them unceasingly.

A telephone call from one of the neighbourhoods in Jerusalem. The resident relates that in kne of the buildings a flat has been let to two/women who are studying/at an ulpan. Their purpose in the new neighbourhood is unclear. The call is transferred to the division for preventive action. A detailed and precise investigation is made, and the conversation is recorded in the minutes. At the conclusion of the conversation, we inquire about the need for so many details. In reply, L., the head of the dept., pulls out an up-to-date with card file. He compares the number of the automobile of the women who were referred to only now with the list of auto numbers of the personnel of the Mission in Jerusalem. Additional comparisons are made, and it becomes clear that the women belong to a certain sect. The auto appears on the list, and it is identified as a car belonging to the Messianic sect in Jerusalem. The division will see to it very soon that the residents of the area will be warned of the danger lurking for

An elderly man appears in the humble office of the department. He sks to speak face to face with someone of the staff. It is a personal matter, he explains. He is turned over to the care of A., the division man for attention to families. There is a lengthy conversation, quite but tense, and again details are recorded. At the conclusion of the conversation, the man rises, warmly shakes hands, and it looks as if a stone has rolled off his heart. "I hope you will do something," he remarks in parting. A. relates: "This man who not too long ago was a man of means sustained economic losses, but he was not discouraged and hopes to rehabilitate himself. The problem is that his wife was accustomed to a high standard of living, and is unable to adjust to the lower standard of living, and thus she arrives home one day and out of the blue brings/a passport, telling her husband that they are emigrating to one of the lands in the West, where she has been promised help. "We will again rehabilitate our lives," she says. Her husband was astonished, for he had already sensed strange/activity on the part of his wife, and asked her: "Where did you get the money for the trip, and how come you're so sure it will work out 'there'." "There is someone looking out for us, " she answers smiling. The husband at once suspected the source of money. He sees suspicious signs, and he asks directly: "Are you in touch with the Mission?" "What does it matter where the money comes from, the main thing is that we can live again like human beings," she answers. The husband, born of a notable family, is unwilling to reconcile himself to the idea, whatever the cost. He slams the door and looks for help, whereupon a friend directs him to YAD L'AKHIM.



"What is it possible to do to help out in such a case?" I asked A. "There are several stages of operation," he replies. First of all, we must encourage the husband, and suggest to him how to act with regard to his wife's plans. It is necessary to find a way to have a serious talk with the wife and to make her understand the high price she may have to pay if her plan takes effect. What interests us is also the source of the enticing proposition. They also have to be put in their place...Another point requiring investigation is how the woman got the passport in the Interior Ministry. There are several suspicious points here, and everything has to be investigated soon and fundamentally. A file was opened. "It won't be closed," A. promises, "until with God's help, the contact with the Mission is severed, and all the problems on the periphery of the case are handled."

We glanced at the file relating to families. The recent economic distress makes it swell daily. There are much harder cases than what has just been told. At least in that instance one side was cooperating. In most of the other instances people who are at the brink of despair are involved, for it must be understood that a Jew who has reconciled himself to the fact that he make contact with the Mission does so for the most part after he has exhausted all other means, and what is especially difficult, of course, is the fact that department does not give financial support to those who turn to it, for the simple reason that it doesn't have the means, especially inasmuch as in most of the instances housing problems are the largest portion of the problems being handled, or also when great financial distress is involved. Indeed there are extra-ordinary instances when a tiny bit of support or not-too-large loan is sufficient to "cool" the fever of despair, but also to avoid situations of blackmail or in order to prove that "it is impossible to sell one's soul", as A. stresses, it is a principle almost always not to enter into financial negotiations. How else, then, can help be given? A. explains to us that there are cases when a quiet hearty convers 19ion, exhibiting concern and interest together with good counsel, in many cases leads to second thoughts among such persons, especially when added to the remarks tion concerning the sin of planning to leave Judaism for filthy lucre. But in are words of admonimany other instances this is insufficient, and it is necessary to act with persistence unceasingly by means of ties with Govt and Municipal bureaus. "We have cultivated a set of : 2 excellent connections with some of the institutions, A. tells us, And indeed, in the ingress we find a closely written calendar of meetings with various clerks at "Perazoth" and in the rehabilitation department of the municipality, with Members of Knesset from various parties, with social workers and lawyers. In Israel, of course, it is impossible without an extensive directory with almost all government and municipal offices. Even if there is not always a successful result, the energetic and dedicated attention to every problem convinces the person turning to them that they are in good . hands. This fact alone is sufficient to reassure them and lead to the severance of ties with the Mission.

In the course of the conversation with the division man for family cases, we overhear additional conversations which come to the department. There are reports and consultations with the staff of the department working in the branches of "YAD L'AKHIM" in the centre and north of the country. From the centre there is a about the missionary school in Jaffa which has taken in that very day two more Jewish children. There is also the joyful news about the removal of the "Krishna" sect from their centre in Herzliya. From the north there comes a report about the activity of the "Guru" sect which, after being removed from its centre in Ramat Gan, transferred its activity to Haifa, and also about the extremist sect "Jehova's Witnesses" ("Ayday Ha'shem"), among whom everyone who is trapped in its net is obliged to serve as a missionary activist to recruit other souls to the sect. A news item which appears in a local paper in Haifa, relating the tragedy caused by this sect, stirs . reverberations and crystallizes public activity against this sect. * significant portion of the activities of the staff in the north is directed toward the curbing of the activity of the missionary Emma Berger who is taking over large areas in the Zicron Yaacov, Binyamina and Pardess Hanna. The staff of the department organize local committees to fight this grave

Someone enters the office and in his hand is a thick envelope containing mostly missionary material which was sent by a well-known Yeshiva head who had received it direct from Canada. The Yeshiva head was shocked to find among the material

a tract directed to rabbis, in which it is related how a long list of "rabbis" converted to Christianity...yes, this problem of missionary propaganda distribution is most serious, L. complains. The post offices are full of packages of books and tracts directed to tens of thousands of homes in Israel. A simple calculation proves that the financial problem does not weigh heavily on the organizations of the Mission. . The package just arrived is worth at least IL500...

It's hard to understand how the department staff manage to handle such a huge variety of problems. True, there is a dedicated and talented staff at their side, activists who do their work faithfully and humbly. But the news that reaches them demands attention besides the guidance for the continuation of operations. L. avoids elaborating on this topic. "You can get from kix stories that might well take up a significant place in the newspaper headlines, but it is an iron rule among us," L. explains, "despite the need to publish in order to expand the public base for the war against the mission, we do not report for publication any detail which is liable to harm, even in the slightest degree, the rescue and preventive operation. There is also a special sensitivity to avoid hurting the families which are involved." We heard this explanation also beforehand in a reply to a journalist who wanted to publish a story about the activities of the department. True, this is a limitation which blocks many possibilities of advertising the struggle, but the rescue of souls is of course prior to any other interest.

This day of activity which, according to L., is most routine, and in which there were no especially astounding occurrences, taught us much about the activities of the department which in a persistent and stubborn battle going on for many years has worked wonders in secret ways of rescue, for the curbing of the criminal phenomenon of soul trapping in Israel, which but for the activity of that handful of enthusiasts with its meagre means in the face of the vast sums poured into the various mission organizations, resembles the war of little David against Goliath. But were it not for this warfare, in which most of its operations are secretive, who know how many victims would have fallen, Heaven forbid, and to what extent there would have been success, Heaven forbid, in spreading their net? On this Sabbath/we read the portion (of the Torah). "Remember what Amalek did unto you," which is dedicated to the war against the Mission, let us express our appreciation by word and deed for the dedicated activity of those young people, unknown soldiers in the war against apostacy. One of the sectarians, Siegfried Seibold, complained about the incident to the police of Zicron Yaacov, which opened an investigation. The local council head, Mr. Moshe Lauer, visited the site and said that he would send workers to erase the inscriptions, but the sectarians did it first. One of the sectarians said that the graffiti were drawn again several times after they were erased, and therefore the sectarians decided to let them remain. The police also report that this is not the first time that pejorative slogans are scrawled in that place, and in the past the police succeeded in catching those responsible, as reported in the local regional paper, "Gefen." EXCERPTS: They have positions of leadership in every extremist group. Some of them rule over what may be characterized "the lunatic fringe" of society, while about others it might be said that their behaviour is governed by characteristics of "aggressive citizenship." All of them are graced with unbounded zeal and some of them require disreputable means, if only to attain their ends. What is equally common to all of them is this: They have all returned their U.S. passport, or have supplemented it with an Israeli one, motivated by an ideal and an ideology. Each one with his ideology: Rabbi Meir Cahana--and Dr. Marcia Friedman, Moshe Hirsch of Neturei Karta (ultra-orthodox antizionist Jewish sect), Dr. Naomi Kiss, who in her day tried to reorganize the Panthers movement -- and Simha Perlmutter, who established the city of Ovot in the Negev; and many others. (The article goes on to describe the background and activities of Cahana, Hirsch, and continues under the heading: "IN THE FOOTSTEPS OF JESUS AND SHOLEM ASCH...)

In time there settled in Ir Ovot in the Negev an "eccentric" American whose feet led him here from Miami, Florida. Simha Perlmutter, now age 49, married to two wives, father of eight, grandfather of four, an Orthodox Jew who is strict on bo th minor and major observances of the commandments -- and believes ... in Jesus. But not as the Christians is his faith. He is attracted to "Rabbi Yeshua" as an historical figure, and supports his feaching "in the manner of the faith of Sholem Asch..." He was a journalist in Miami, propagandized on behalf of aliya, but met with hostility when he sought assistance for arranging his own emigration to Israel, because of his "deviation" in the matter of Yeshua. In 1966 he arrived in Israel. In the empty desert near Ein Yahav, with two other families that had accompanied him, he found his future. They said about him: "The man is mad!" And indeed, they looked at him as "a strange critter", someone you do n't know "how to digest." He had to fight an exhausting campaign, also in the courts, in order to be recognized as a Jew, and to be entitled to live in a place altogether isolated, \(\sqrt{and desolate}, \) to make a livelihood from a humble kiosk for wayfarers and from primitive "agriculture." His slogan was "stubbornness", and this was the second title he bestowed upon his tiny settlement. His troubles multiplied, until/Yeshayahu Gavish, former Southern Commander, had pity on him and those with him, and moved them over near to Hatseba, where there was more water and better conditions. It was only in 1977 that the authorities deigned to recognize Ir Ovot as a settlement. Its members chose the kibbutz lifestyle "in order that no one among us would ask for himself a portion in the general property, " (MOHE) as he told me this week. Ir Ovot, which was a mirage in the desert, yielded the fruit of "stubbornness". Today there are 15 families living on the site, 55 persons living from a toy plant, from a trucking company, and from winter vegetables. "But not this year. We are not working the soil during the year of sh'mita" (Sabbatical year). Has Perlmutter come into his inheritance? Not quite. "I am now weighing seriously entry into politics. What for? Is it necessary to say that the State is crying for change? Look, it's impossible just to sit quietly..." (END EXCERPTS)

QUOUE: Ir Ovot, the "Jewish-Christian" settlement near Hatzeva in the Arava, has applied to the High Court of Justice demanding government recognition of its existence and its name. The Interior Ministry has opposed such acknowledgment because of the beliefs of the 15-family kibbutz, founded in 1966 and granted Jewish Agency recognition in 1977. Its members call "Rabbi" Jesus the last and greatest prophet. The ministry's committee on settlement names has for years opposed the name Ir Ovot, arguing that the Biblical site of that description was in Sinai. "They have suggested that we call our settlement Sheizaf Hatzeva, She zaf or Ohalim," says Ir Ovot founder Simha Pearlmutter, who last week announced his candidacy for the Knesset as leader of the Ayeka party.

In their application to the High Court, the settlers point out that the Ariel Encyclopedia and the Biblical Encyclopedia (Encyclopedia Mikrai'it) both refer to the location as a possible site of the Biblical Ir Ovot, as does Zev Vilnay in his "Sinai: Past and Present." As one of Pearlmutter's two wives, interviewed in Jerusalem, put It: "Why should we change our baby's name when he is 15 years old because some committee says so?"

The kibbutz, which was founded as a moshev is shitufi and is a member of the Ihud Hakl'ai moshev association rather than one of the kibbutz movements, is based on agriculture, trucking and an arts and crafts industry. Pearlmutter says that Ir Ovot is in fact a member of the Arava Regional Council, but because of the withholding of rightful recognition, it has been denied various forms of government and council assistance.

Pearlmutter describes his book, "The Tents of Shem," which he says will soon be published by Vantage Press in New York, as dealing "with the kidnapping of Rabbi Yeshua (Jesus) by the Christians and his eventual release from captivity by the Jews." Pearlmutter's Ayeka party derives its name from "Eretz Yisrael Kalat Hashem," meaning "The Land of Israel is the bride of the Creator." The initials in Hebrew also spell God's first question to Adam after the fall: "Ayeka?" or "Where art thou?"

The settlement is populated mostly by former Americans, both Jews who believe in the divinity of Jesus and Christians who have an affinity for the Jews and the holy land. The 45-year-old Pearlmutter, who lives in Ir Ovot with his two wives, Judy and Jan, two parents, eight children, and three grandchildren, is the sect's Jewish-born leader. END

The mainstream Protestant organization, which claims to represents one-quarter of U.S. Christians, "has taken an increasingly anti-Israel stand since the Six Day War despite earlier support for Israel," Gold said. Following pressure from the Eastern churches, a proposal has been made to demand ending aid to Israel for "denial of human rights" in the territories. The churchmen will spend a few days in Israel and also tour some Arab countries. But Maass said they should be questioned (MOHE)



QUOTE : A toplevel delegation of the U.S. NCC which represents 40-50 million American Christians, arrived in Israel yesterday for four days of talks with Jewish and Arab leaders. No meetings with government officials have been scheduled. The members of the NCC Mideast panel were due to arrive on Monday from Jordan, where they were received by king Hussein, but they were delayed by snow and flooding at the Allenby Bridge. They finally arrived by a ir via Athens. The panel is studying five "issues": the right of the Palestinian Arabs to selfdetermination; security in the region, human rights, settlements in the West Bank, and religious topics. Israeli officials and Jewish leaders are particula rly irritated by the fact that the study of human rights involves only Israel. The group's earlier hearings in Washington were boycotted by all major Jewish organizations, which insisted that any discussions between the two faiths must be between equals. They also objected to the group's terms of reference, which, they said, deal only with alleged Israeli misdeeds. But the AJC, which boycotted the hearings, did offer to host the group during its visit to "Jewish" Jerusalem. The "Arab" side of the tour is being arranged by the Middle East Council of Churches, based in East Jerusalem.

The panel, headed by Nev. Tracey Jones, Jr., chairman and general-secretary of the United Methodist Board of Global Ministries, is due to see members of "Peace Now" and meet with a wide range of MKs. The group will also visit Yad Vashem and the "Good Fence" on the Lebanese border. Mambers of the panel include: Bishop Maximos Aghiorgoussis of the Gk. Orth., Archbish. Manoogian of the Armenian Chur, Dr. Dorothy Marple, V.P. of the NCC of Lutheran Ch. Dr. Oscar McCloud of the Presby Ch. Rev. Robt Neff, Ch. of Brethren, Rev. A.Post, Pres. United Ch. of Christ, Rev. Jeanne A. Powers, Meth.Ch., and Wm. Thompson of Presby. Church. (END ARTICLE)

QUOTE : A delegation of the Council of Churches in the U.S. on its own initiative yesterday toured the West Bank in Judea and Samaria, and in conversations with four mayors expressed its opposition to Jewish settlements in the region, and also to the Israeli interpretation of the autonomy plan. This is the first time that a delegation of this kind has visited the territories. The members of the delegation rejected the plan of tours and visits which government sources proposed to them, and insisted that they be free of any official Israeli escort. In the course of the tour the delegation met with mayors of Hebron, Nablus, Al-Bira and Bethlehem. Arab sources reported that most of the members of the delegation surprised their hosts in exhibiting sympathy for the Palestinian problem and in their opposition to the policy of Israel in the territories. There were those who declared that they had especially come into the area in order to prove whether or not there was substance to the charges being raised against Israel. Bethlehem Mayor Elias Freiji said last night that the visit of the delegation in his office was gratifying: "They exhibited sympathy for our just causes, and I had the impression that they were persuaded that in the present situation the Israeli government is not seeking peace, but only speaking about peace. QUOTE: A top-level delegation of the N.C.C. in the U.S. arrived this weekend for a visit of four days in Israel and the occupied territories. This influential council, representing about 40-50 million Christians, mainly Protestants, most of them members of progressive and liberal congregations considered in recent years to be generally Pro-Arab in distinction from the Conservatives who are supporters of Israel. The aim of the delegation is to explore five principal issues: The right of the Palestinians to self-determination, security in the region, human rights, settlements in the West Bank, and religious issues. Know-ledgeable sources attribute great significance to the evaluations of the group.

The delegation numbers 16 persons, among the Archbishop Maximos and the Armenian Archbishop Manoogian, which of course permits access to the patriarchates of these ancient communities, and also three black well-known clergymen. They have also held meetings in the U.S., which were boycotted by Jowish organizations, which has charged that "the delegation is one-sided," but the director of the American Jewish Committee in Jerusalem, Dr. Bernard Resnikoff, is giving assistance to the arganization in arranging meetings in Israel, and they will meet with Mayor Teddy Kollek, with MKs Shulamit Aloni, David Glass, and others, as well as with jurists and journalists (among them David Krivine, Sokolow laureate in journalism for his investigation of the charges of torture which he sought to refute), and "Peace Now" members and members of the Interfaith Association. They were also scheduled to meet with Supreme Court Vice President Hayam Cohen, but the snowfall caused a disruption in their calendar of meetings and the meeting was not held, and it is still unclear. whether administration officials will agree to meet with them. They will also visit at "Yad Vashem" and "The Good Tence" on the lebanon border. Their journey began in Egypt and Syria, and proceeded to Rabbat-Ammon, where they were received by King Hussein, but because of the closing of the Jordan bridges in the wake of the snowstorms they were unable to to arrive/as scheduled at the beginning of last week, and were compelled to fly here via Athens.

"The fact that notwithstanding the large expenses, the loss of time, and the complications of travel involved in the change of course, proves our strong determination to know at close hand the Israeli side," delegation members explained. The head of the delegation is elergyman Tracy Jones, one of the Methodist Church leaders. At the end of the week they toured for two days in the West Bank, where the representative of the "Quakers", Jim Fine, hosted them in behalf of the Niddle East Council of Churches, They also visited Bir Zait University, met with mayors



At first the inclination of official (Israeli) circles was to ignore the visit of the delegation inasmuch as Jewish organizations in the USA had boycotted the group, most of whose members are considered pro-Palestinian, something which was reflected in the definition of the aims of the tour, but finally it was felt that it would be better to maintain direct contact with the delegation. Dr. Claire Rendle, the secretary of the delegation, told me that the tours and the meetings in Israel were "very tiring but most useful." Spe avoided entering into specific details. END

The group plans to hold talks upon its return to the USA with representatives of the Jewish community and the Palestinian community there. The Council comprises 32 Protestant and Eastern Churches with some 43 million believers. Its recommendations will be of considerable weight in the shaping of American policy. END

JTA Correspondent David Appel met with him along the way between Askelon and Gaza near Erez. The man related that to date he has managed to pass through six countries carrying the word of Jesus for the love of man and for peace among the nations. According to him, he has already march ed some 28,000 KM. END




